**A. Justification**

CBP Form 6043, *Delivery Ticket*, is used to document transfers of imported merchandise between parties. This form collects information such as the name and address of the consignee; the name of the importing carrier; lien information; the location of where the goods originated and where they were delivered; and information about the imported merchandise. CBP Form 6043 is filled out by warehouse proprietors, carriers, Foreign Trade Zone operators and others involved in transfers of imported merchandise. This form is authorized by 19 USC 1551a and 1565, and provided for by 19 CFR 4.34, 4.37 and 19.9. The information is to be used by CBP officers to document transfers of imported merchandise between parties.

The information on the Delivery Ticket, Form 6043 can be transmitted electronically through the Automated Manifest System (AMS). It is estimated that approximately 20 percent are filed through AMS. This information can also be submitted in person, by fax, or email. CBP ports work with their local trade community to ensure they have the necessary contact information to fax or email Form 6043.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

Without this information, CBP would not be able to document transfers of imported merchandise between parties.

Public comments were solicited through two Federal Register notices published on October 31, 2012 (Volume 77, Page 65900) on which no comments were received, and on January 8 (Volume 78, Page 1219) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

**Public Cost**

The estimated cost to the respondents is \$1,320,000. This is based on the estimated burden hours (66,000) multiplied (x) the hourly rate (\$20.00).

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

The estimated annual cost to the Federal Government associated with the review of these records is **\$1,394,400**. This is based on the number of responses (200,000) that must be reviewed (x) the time to review and process each response (.166 hours) = 33,200 hours (x) the average hourly rate (\$42.00) = \$1,394,400.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There is no change to the information collected or to CBP Form 6043.
