# Foreign Graduate Medical School Consumer Information Reporting Form

### A. Justification

This is a request for a new collection to obtain consumer information from foreign graduate medical institutions that participate in the William D. Ford Federal Direct Loan Program (Direct Loan Program) as authorized under Title IV of the Higher Education Act of 1963, as amended, (HEA). The request is to gain approval of a form for reporting specific graduation information to the Department of Education (Department) with a certification signed by the institution's President/CEO/Chancellor.

The foreign medical institutions are to provide to the Department the following information for all U.S. students attending its approved graduate medical programs: ontime graduation rates for U.S. student completing the program; the median and mean Title IV loan debt incurred by U.S. students who completed the program, the median and mean private loan debt incurred by U.S. students who completed the program; the median and mean institutional financing debt incurred by U.S. students completing the program; and the total median and mean debt incurred by U.S. students who completed the program.

The Department's regulations, at <u>34 CFR 668.14(b)(7)</u>, require Title IV participating institutions to submit reports to the Department containing such information as the Secretary may reasonably require to carry out the purposes of the Title IV, HEA programs. This is being done to improve consumer information by providing more specific consumer information to prospective U.S. medical students at foreign institutions.

The information calculated and provided by the foreign medical schools will be published on a Departmental <u>consumer web site</u>.

3. The information that is reported to the Department requires a "wet" signature from the institution's President/CEO/Chancellor so the report cannot be submitted electronically at this time.

There is no duplication of data as a result of the collection of this information.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden. No small businesses are impacted by this collection.

Without the collection and dissemination of the information via the Department's consumer web page prospective U.S. students at a foreign medical school may not have a clear indication of total costs of the medical program they wish to attend or an indication of the successful completion by other U.S. student's in that particular program. This will aid in prospective U.S. students making more informed decisions, and avoiding overborrowing in the Direct Loan Program.

The comment was reviewed and some changes were made to the instructions and form based on the suggestions made by the commenter. The burden time was increased based on the comment.

The Department has revised its estimate of the time that it will take the 25 affected institutions to fulfill the reporting requirements. Based on comments received from a sector of the affected parties, we are persuaded that the original time to complete the reporting mistakenly excluded the time for data gathering and required calculation time and only identified the time needed for the completion of the form to be submitted to the Department.

The Department estimates an average of 16 hours is required to complete the reporting requirements for a total of 400 hours (25 institutions by 16 hours).
