Introduction

This can refer to those who have emigrated from Venezuela and are now living outside the country, it can also refer to individuals who spend part of their time in Venezuela and part of their time in another country (countries), or it can refer to the children and grandchildren of emigrants from Venezuela – as long as they feel an affinity for Venezuela as a type of "home."

Depending on how the fund is structured, USAID or another partner might offer some sort of credit enhancement or guarantee to reduce the risk of lending to Venezuelan enterprises. Enterprises receiving funding would be selected and vetted based on strict criteria and would be expected to conform to US standards of transparency and audit.
