<p><b>Who must comply?</b></p>	<p>Owners, agents, masters, towing vessel operators, or persons in charge of barges loaded with Certain Dangerous Cargoes (CDC) or having CDC residue operating on the inland rivers located within the Eighth and Ninth Coast Guard Districts.</p>
<p><b>What is this collection about?</b></p>	<p>This information is used to ensure port safety and security and to ensure the uninterrupted flow of commerce.</p>
<p><b>Where do I find the requirements for this information?</b></p>	<p>Title 33 CFR 165.830 &amp; 165.921 are available at—<a href="http://ecfr.gpoaccess.gov">http://ecfr.gpoaccess.gov</a>, select TITLE 33 – Navigation and Navigable Waters, and follow to Part 165.</p>
<p><b>When must information be submitted to the Coast Guard?</b></p>	<p>The information must be provided to the Coast Guard (CG) prior to moving a CDC barge into the Regulated Navigation Area (RNA) and at designated reporting points within the RNA.</p>
<p><b>How is the information submitted?</b></p>	<p>The information is submitted to the CG’s Inland River Vessel Movement Center (IRVMC). <p><b>What happens when complete information is received?</b></p>	<p>This information will be reviewed by the CG. No specific documentation will be issued by the CG.</p>
