<b>PRODUCT CATEGORY</b>	<b>CHECKLIST CODE(S)</b>	<b>DEFINITION/EXAMPLE</b>
Wet ice packed broilers and fryers, shipped in bulk	Checklist A Group 01: 001	Broilers and fryers packaged in bulk and preserved using wet ice (frozen water ice) only (not solidified carbon dioxide dry ice). Products cannot be cooked or smoked first. Products may be whole or in parts.
Bulk dry ice packed broilers and fryers	Checklist A Group 01: 002	Broilers and fryers packaged in bulk and preserved using dry ice (solidified carbon dioxide) only. Products cannot be cooked or smoked first. May be in whole or in parts.
Consumer packaged tray packed broilers and fryers, chilled	Checklist A Group 01: 003	Broilers and fryers consumer packaged using tray type packaging. Products cannot be smoked or cooked first. May be in whole or in parts.
Other broilers and fryers, frozen, including individually quick frozen and vacuum packed etc.	Checklist A Group 01: 004-006	All other broilers and fryers including frozen. Includes vacuum packed, individually quick frozen (IQF) or any other packaged types. Products cannot be smoked or cooked first. May be in whole or parts.
* Roasters and capons (usually under 20 weeks of age), including frozen	Checklist A Group 01: 007-008	Includes roaster and capons of all packaging sizes and all frozen preservation methods. Products cannot be smoked or cooked first. May be in whole or in parts.
* Hens and/or fowls (including frozen whole or parts)	Checklist A Group 01: 009-012	Includes egg producing type hens and/or fowls. Also include all breeder-types hens, as well as males such as roosters. Products cannot be cooked or smoked first. May be whole or in parts.
Turkeys (including frozen whole or parts)	Checklist B Group 01: 001-006	Includes all shipment sizes of fryer roaster turkeys, young turkeys, and old turkeys frozen whole or in parts using any freezing preservation method. This category also includes ground turkey, and turkey cutlets. None of the products may be smoked or cooked first.
*Other poultry and small game, whole and parts incl. ducks, pigeons, pheasants, etc.	Checklist C Group 01: 001-009	Examples would include; ducks, geese, pigeons (squab), guinea hens, rabbits, partridges, pheasants, quail or any other poultry and small game which is <b>not</b> chickens or turkeys. May be whole or in parts. Products cannot be smoked or cooked first.
Cooked, smoked & processed poultry & small game (excl. soup), contains 20 percent or more meat	Checklist D Group 01: 001-008	Includes any poultry either whole or in parts that has been cooked or smoked as one of the processes. The poultry may be fully or only partially cooked. The poultry may be subsequently frozen (typically IQF) after it has been cooked or smoked.  Examples include all canned poultry (not soups) with 20 percent or more poultry. Luncheon style deli meat products such as chicken bologna, chicken ham, turkey ham, and turkey salami belong in this category. Dinner roast/rolls are included in this category. Frankfurter and sausage type products made predominantly of poultry, such as chicken dogs, turkey sausage, turkey bratwurst, or breaded corn dogs belong here. Breaded poultry products are classified in this category.
Other (including secondary products and/or misc. receipts)		Any secondary products and/or miscellaneous receipts.
