## **Education Study Discussion Guide**

1. Introduction: Taping, Mirror, Speak one-at-a-time, no wrong answers, open-honest and casual discussion!

2. Before saying anything aloud, please write down what you understand to be the main idea from all you have just seen, heard and read.
  - What other ideas are you getting from this communication?
3. Next, I would like you to jot down what is giving you these ideas. What did you see, hear or read that caused you to write down those ideas?
4. What are the most relevant and personally meaningful aspects of the messages you just reviewed?
  - Why do you feel this way?

5. What, if anything, is this telling you about paying for college that may be new or different from what you may have already known or suspected?
6. Has anything contained in these ideas changed the way you feel about looking into obtaining federal money for college?
  - What was that?

**PROBE:** What, specifically, did you see, hear or read that makes federal financial aid different or unique from other sources of educational

funding you may know about?

7. To what extent do these ideas make you more likely to investigate federal financial aid for college?

PROBE: What about it did you find to be most compelling?

8. Now I would like you to focus specifically upon only the tagline in this communication. What is the tagline alone suggesting to you about federal financial aid for college?
