TSCA Title VI

The Formaldehyde Standards for Composite Wood Products Act, enacted as Title VI of the Toxic Substances Control Act (TSCA), 15 U.S.C. 2697 established formaldehyde emission standards for composite wood products. In order to ensure compliance with the emission standards, EPA established a third-party certification program whereby third-party certifiers (TPCs), which are accredited by EPA-recognized accrediting bodies (ABs), certify composite wood products.





I. Purpose


The purpose of this Recognition Agreement between the Environmental Protection Agency's (EPA) Office of Pollution Prevention and Toxics (OPPT) and Laboratory AB 1 is to recognize Laboratory AB 1 as an EPA-Recognized Laboratory Accreditation Body (EPA-Recognized Laboratory AB) working in cooperation with the EPA Toxic Substances Control Act (TSCA) Title VI Third-Party Certification Program. The primary function of an EPA-Recognized Laboratory AB is to provide an impartial verification of the competency of laboratories used by a TSCA Title VI Accredited Third-Party Certifier (TSCA Title VI Accredited TPC).

II. Background

The regulations codified at 40 CFR Part 770, Subpart B, establish a third-party certification program that helps ensure compliance with the formaldehyde emission standards for composite wood products pursuant to the requirements of the Formaldehyde Standards for Composite Wood Laboratorys Act, or Title VI of

TSCA. In order to verify that a Laboratory Accreditation Body (Laboratory AB) is capable of performing an adequate assessment of laboratories that conduct formaldehyde emission testing, EPA enters into Recognition Agreements with the Laboratory ABs that apply to EPA and (1) are signatories to the International Laboratory Accreditation Cooperation (ILAC) Mutual Recognition Agreement (MRA) or an equivalent oversight body, (2) conform with International Organization for Standardization (ISO) and International Electrotechnical Commission (IEC) 17011:2004(E) and (3) demonstrate competence to perform accreditation activities for laboratory accreditation according to ISO/IEC 17025:2005(E).

III. Definitions

The following definitions can also be found in 40 CFR section 770.3.

Accreditation Body (AB) means an organization that provides an impartial verification of the competency of conformity assessment bodies such as TPCs.

EPA Recognized Laboratory Accreditation Body or EPA Recognized Laboratory AB means a Laboratory AB that has a recognition agreement with EPA under the TSCA Title VI Third-Party Certification Program.


Laboratory Accreditation Body or Laboratory AB means an accreditation body that accredits laboratories to ISO/IEC 17025:2005(E).

TSCA Title VI Accredited Third-Party Certifier (TSCA Title VI Accredited TPC) means an organization or entity that is accredited by an EPA recognized Laboratory AB and an EPA recognized Laboratory AB pursuant to 40 CFR section 770.7(c)(1).

Under TSCA Title VI, EPA must promulgate regulations to implement the formaldehyde emission standards in a manner that ensures compliance with those standards, including provisions related to a third-party testing and certification program. In exercising its discretion under the Act, EPA required third-party certifiers, and their laboratories that perform TSCA Title VI formaldehyde emissions testing, to be accredited by accreditation bodies in order to participate in the TSCA Title VI Third-Party Certification Program. Pursuant to the regulations at 40 CFR Part 770, Subpart B and as outlined in the Recognition Agreements, EPA-Recognized Laboratory ABs will accredit laboratories used by TSCA Title VI Accredited TPCs for participation in the TSCA Title VI Third-Party Certification Program and provide an impartial verification of the competency of those laboratories.

V. Basis and Substance of Understanding





After reviewing the information submitted by Laboratory AB 1 pursuant to 40 CFR section 770.7(b)(2), the EPA has determined that Laboratory AB 1 meets the application requirements for the TSCA Title VI Third-Party Certification Program.

Pursuant to 40 CFR Part 770, Subpart B, Laboratory AB 1 agrees to:

- act in accordance with all provisions and requirements listed under the EPA-Recognized Laboratory AB responsibilities at 40 CFR section 770.7(b)(3) including notifications to the EPA and to the applicable EPA recognized Laboratory AB for the activities listed in 40 CFR section 770.7(b)(3)(k); and
- electronically report via the EPA's Central Data Exchange (CDX) at [Website address] for any reporting requirements under 40 CFR section 770.7(b).


Pursuant to 40 CFR Part 770, Subpart B, the Office of Pollution Prevention and Toxics as the overseeing EPA Office for the TSCA Title VI Third-Party Certification Program agrees to:

The TSCA Title VI Third-Party Certification Program is managed as a part of the OPPT NPCD Formaldehyde Program.

The responsibility for implementing and support of the program lies with NPCD personnel.

IX. Revision or Termination

This Recognition Agreement shall be effective upon signature, and shall remain effective for 3 years, after which time the EPA Recognized Laboratory AB will need to reapply via the EPA's CDX to renew its accreditation in accordance with 40 CFR section 770.7(b)(2)(ii). The Recognition Agreement may be amended by agreement of both parties at any time prior to its expiration or termination. The parties shall seek to resolve any dispute concerning the Recognition Agreement through good faith discussions. The Recognition Agreement may be terminated at any time with prompt written notice by Laboratory AB 1, or EPA may also suspend, revoke, or modify the Recognition Agreement pursuant to 40 CFR section 770.7(e)(2)-(3).

X. Notice of EPA's Authority

Nothing in this agreement shall be interpreted to curtail EPA's authority to independently revoke the accreditation of any TSCA Title VI Accredited TPC or TPC laboratory, inspect or audit any TSCA Title VI Accredited TPC or TPC laboratory, or otherwise enforce TSCA Title VI.

Recognition Agreement between the Office of Pollution Prevention and Toxics of the U.S. Environmental Protection Agency and Product AB 1

I. Purpose

The purpose of this Recognition Agreement between the Environmental Protection Agency's (EPA) Office of Pollution Prevention and Toxics (OPPT) and Product AB 1 is to recognize Product AB 1 as an EPA-Recognized Product Accreditation Body (EPA-Recognized Product AB) working in cooperation with the EPA Toxic Substances Control Act (TSCA) Title VI Third-Party Certification Program. The primary function of an EPA-Recognized Product AB is to provide an impartial verification of the competency of TSCA Title VI Accredited Third-Party Certifiers (TSCA Title VI Accredited TPCs).

II. Background

The regulations codified at 40 CFR Part 770, Subpart B, establish a third-party certification program that helps ensure compliance with the formaldehyde emission standards for composite wood products pursuant

to the requirements of the Formaldehyde Standards for Composite Wood Products Act, or TSCA Title VI. In order to verify that a Product Accreditation Body (Product AB) is capable of performing an adequate assessment of third-party certifiers, EPA enters into Recognition Agreements with Product ABs that apply to EPA and (1) are signatories to the International Accreditation Forum, Inc. (IAF) and endorsed for the IAF Multilateral Recognition Arrangement (MRA) Level 3 or an equivalent oversight body, (2) conform with International Organization for Standardization (ISO) and International Electrotechnical Commission (IEC) 17011:2004(E), (3) demonstrate basic competence to perform accreditation activities for product certification according to ISO/IEC Guide 65:1996(E), and (4) demonstrate competence to perform accreditation activities for inspection certification according to ISO/IEC 17020:1998(E).

III. Definitions

The following definitions can also be found in 40 CFR section 770.3.

Accreditation Body (AB) means an organization that provides an impartial verification of the competency of conformity assessment bodies such as TPCs. EPA-Recognized Product Accreditation Body or EPA-Recognized Product AB means a Product AB that has a Recognition Agreement with EPA under the TSCA Title VI third-party certification program. Product Accreditation Body (Product AB) means an accreditation body that accredits conformity assessment bodies to ISO/IEC Guide 65:1996(E) and ISO/IEC 17020:1998(E). TSCA Title VI Accredited Third-Party Certifier (TSCA Title VI Accredited TPC) means an organization or entity that is accredited by an EPA-Recognized Product AB and an EPA-Recognized Laboratory AB pursuant to 40 CFR section 770.7(c)(1).

IV. Authority

Under TSCA Title VI, EPA must promulgate regulations to implement the formaldehyde emission standards in a manner that ensures compliance with those standards, including provisions related to a third-party testing and certification program. In exercising its discretion under the Act, EPA required that third-party

certifiers be accredited by accreditation bodies in order to participate in TSCA Title VI Third-Party Certification Program. Pursuant to the regulations at 40 CFR Part 770, Subpart B and as outlined in the Recognition Agreements, EPA-Recognized Product ABs will accredit third-party certifiers for participation in the TSCA Title VI Third-Party Certification Program and provide an impartial verification of the competency of third-party certifiers.

V. Basis and Substance of Understanding

After reviewing the information submitted by Product AB 1 pursuant to 40 CFR section 770.7(a)(2), the EPA has determined that Product AB 1 meets the application requirements for the TSCA Title VI Third-Party Certification Program.

Pursuant to 40 CFR Part 770, Subpart B, Product AB 1 agrees to:

- act in accordance with all provisions and requirements listed under the EPA-Recognized Product AB responsibilities at 40 CFR section 770.7(a)(3) including notifications to the EPA for the activities listed in 40 CFR section 770.7(a)(3)(k); and
- electronically report through the EPA's Central Data Exchange (CDX) at [Website address] for any reporting requirements under 40 CFR section 770.7(a).

Pursuant to 40 CFR Part 770, Subpart B, the Office of Pollution Prevention and Toxics as the overseeing EPA Office for TSCA Title VI Third-Party Certification Program agrees to:

- recognize Product AB 1 as an EPA-Recognized Product AB for the TSCA Title VI Third-Party Certification Program; and
- provide guidance and interpretation, if requested and to the extent possible, for the TSCA Title VI Third-Party Certification Program protocols and criteria and provide notice to Product AB 1 when the TSCA Title VI Third-Party Certification Program protocols, criteria, and performance standards have

VI. Duration of Recognition Agreement

The Recognition Agreement shall be valid for 3 years as stated in 40 CFR section 770.7(a)(2)(ii) and is subject to the renewal provisions stated therein.

VII. Management and Implementation

The TSCA Title VI Third-Party Certification Program is managed as a part of the OPPT NPCD Formaldehyde Program. The responsibility for implementing and support of the program lies with NPCD personnel. VIII. Funding

All costs incurred by Product AB 1 to accredit third-party certifiers are the responsibility of Product AB 1. Nothing in this Recognition Agreement shall be interpreted to constrain Product AB 1's discretion to recover any costs by assessing fees to TSCA Title VI Accredited TPCs for its services.

This Recognition Agreement shall be effective upon signature, and shall remain effective for 3 years, after which time the EPA Recognized Product AB will need to reapply via the EPA's CDX to renew its accreditation in accordance with 40 CFR section 770.7(a)(2)(ii). The Recognition Agreement may be amended by agreement of both parties at any time prior to its expiration or termination. The parties shall seek to resolve any dispute concerning the Recognition Agreement through good faith discussions. The Recognition Agreement may be terminated at any time with prompt written notice by Product AB 1, or EPA may also suspend, revoke, or modify the Recognition Agreement pursuant to 40 CFR section 770.7(e) (2)-(3).

X. Notice of EPA's Authority

Nothing in this agreement shall be interpreted to curtail EPA's authority to independently revoke the accreditation of any TSCA Title VI Accredited TPC, inspect or audit any TSCA Title VI Accredited TPC, or otherwise enforce TSCA Title VI.

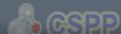

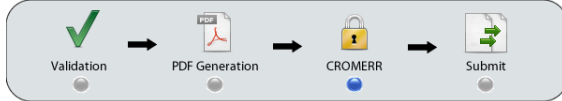
