## **Reason for Revision:**

- USCIS is revising the Form I-824 to clarify the instructions and to make them easier to understand for the customer.
- USCIS is also revising the instructions to clarify that the form should be filed with U.S. Customs and Border Protection if the applicant is the beneficiary of an approved Form I-192 or Form I-212 and in need of a duplicate of his or her original decision. USCIS is also amending the Form I-824 to include additional information regarding the collections required by the Department of State (DOS), to process follow-to-join immigrant visa applications for certain dependent family members abroad. The additional information will enhance communication with DOS and allow the follow-to-join process to be completed more efficiently.
