### 1. Please describe the purpose of the project or program:

The Federal Emergency Management Agency (FEMA) Office of Protection and National Preparedness (PNP) Grant Programs Directorate (GPD) collects Environmental Planning and Historic Preservation (EHP) screening information authorized by OMB ICR No. 1660-0115. This PTA is being conducted as part of the collection renewal process. The National Environmental Policy Act (NEPA) requires that each Federal agency examine the impact of its actions on the human environment, to look at potential alternatives to that action, to inform both decision-makers and the public of those impacts through a transparent process, and to pursue mitigation if necessary. It does not mandate necessarily that the alternative with the least environmental impacts be selected. A NEPA compliance review process often addresses compliance with other Federal regulations, including the National Historic Preservation Act (NHPA), the Endangered Species Act (ESA), the Clean Water Act (CWA), the Migratory Bird Treaty Act (MBTA), and other authorities to streamline the overall compliance review process.

Environmental Planning and Historic Preservation (EHP) compliance is the process by which the FEMA GPD can ensure that projects that are funded through federal grants are compliant with existing laws and regulations regarding the environment and historic preservation. In order to assure compliance, project information must be provided by the grantee that describes what the action, how it would be accomplished, and where it would take place. To simplify the collection of required information, and to streamline compliance determinations with relevant laws, it was necessary to standardize the format in which information is submitted to FEMA GPD. The GPD Environmental Screening Form (Screening Form) provides a user-friendly format for collecting essential information.

The information collected by FEMA GPD from grant recipients via the Screening Form will be used for EHP reviews that will examine the potential environmental, historic, and cultural impact of the projects for which grant funding is requested before approving the project, as required by NEPA, NHPA, and other Federal environmental and historic preservation laws and regulations. Grantee and subgrantees are state, tribal, and local governments as well as eligible private non-profit organizations. The personally identifiable information (PII) requested under this collection is limited to point of contact (POC) information of Grantees and subgrantees. This PII is used for the sole purpose of contacting grantees and subgrantees regarding continued eligibility of federal grant funds and compliance with federal statutes and regulations.

FEMA GPD owns and uses the Project Information Management System (PIMS), at a headquarters level as a repository for EHP Screening Form information and to assist in processing EHP compliance for grants. PIMS is a Microsoft Access based database and is only accessible by FEMA staff.
