Excluding the cost of adding additional data fields, we are probably talking about \$1,000.00 to \$1,500.00 in cost to completely answer all of the questions on Attachment F PESP Strategy-Progress Reporting Form. Specially, the below questions are not currently collected:

- 1. The first question in the Pesticide Risk Reduction and Usage section that request information on pesticide use. (Total Amount of Pesticide Applied (or purchased only if application data is not available))
- 2. The fifth question in the Organizational Profile Measures section that request the total number of nonchemical treatments. This data is not captured in any easy way to produce. However, as we move forward, we may be able to capture this data in the future.

There are other measures that we don't currently capture however, those measure were not noted as a required reporting measure.
