OPHPR STORYTELLING GOALS

1. <u>Showcasing the nature of the preparedness</u> <u>and response challenge</u>: Something observed at ground level that clearly illustrates why the work is necessary.

Ex. A story describing factors unique to the community which created a challenge and how you overcame them.

2. <u>Illustrating the public health contribution:</u>
Examples that prove **Public Health** preparedness and response not only makes a difference, but also illustrates the unique approach it brings to the issue.

Ex. Tying an event or outcome specifically to public health preparedness and response involvement, management, oversight, or ownership.

3. <u>Supporting the evidence-base</u>: Examples that compliment qualitative research on evidence based interventions.

Ex. Linking an effected program to a specific population and the potential health outcomes estimated due to the success, impact, funding-related activity.

4. <u>Demonstrating return on investment:</u>

Demonstrating awareness of how you use funds and demonstrating you are fiscally responsible and transparent.

Ex. The purchase of equipment, how it is used, any interoperability, and a sustainment plan.
