HOW TO USE THE ACTIVITY MONITOR

- ▶ It is very important that you wear the activity monitor ALL DAY, EVERY DAY beginning at 8 PM on / / and through 8 PM on / / ...
- > Do not wear the monitor when you are showering, bathing, or swimming.
- Please put the monitor on your non-dominant wrist (opposite your writing hand) with the black disk facing toward the fingers.
- Make sure the strap fits you snugly because it will not record your activity accurately if it is loose. Wear the strap tight enough so that the monitor does not move when you are being active.
- You can wear the monitor underneath or over your clothes.
