




Fingerprints Accepted – Prints 2-5




Capture Fingerprints – Prints 1 and 6 (Thumbs)












6a: Alternate Fingerprint – Bandaged Finger




6b: Alternate Fingerprint – Split Fingers for Large Hands




Card Replacement Modal - Unable to Locate Applicant




Card Replacement Modal – Unable to Determine Eligibility


