## 6b: Alternate Fingerprint – Split Fingers for Large Hands





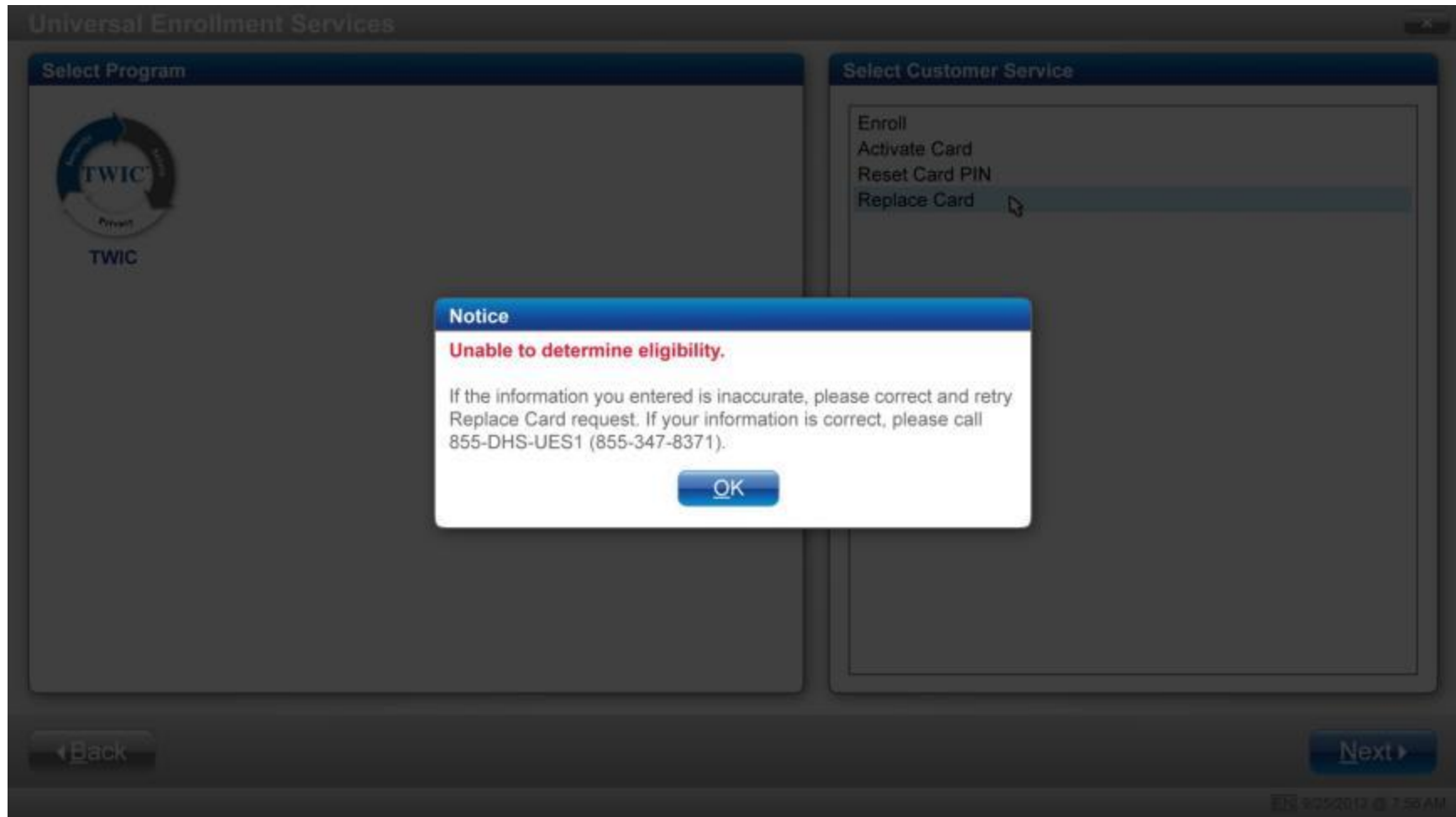
## Card Replacement Modal - Customer Ineligible



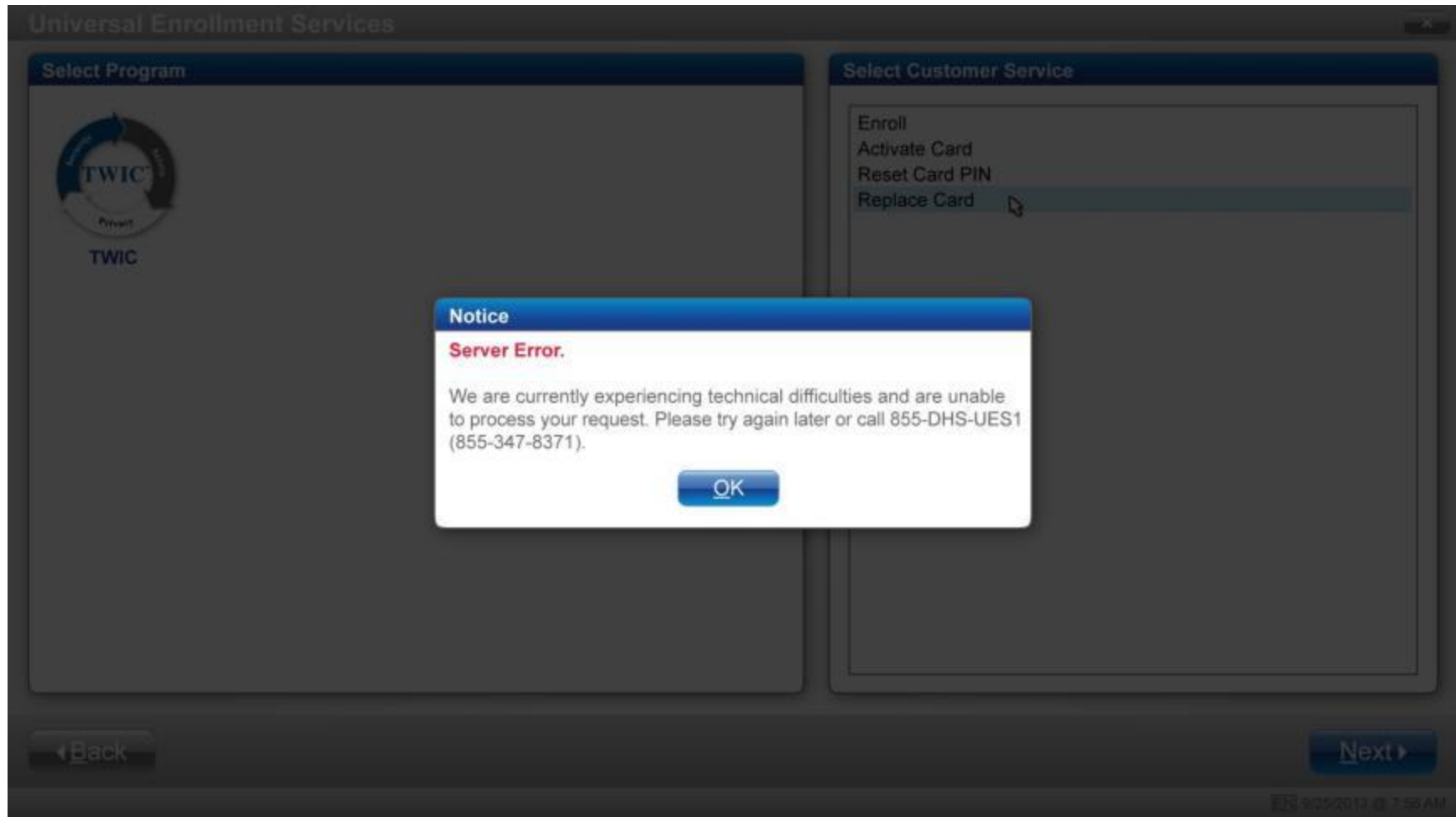
## Card Replacement Modal - Unable to Locate Applicant

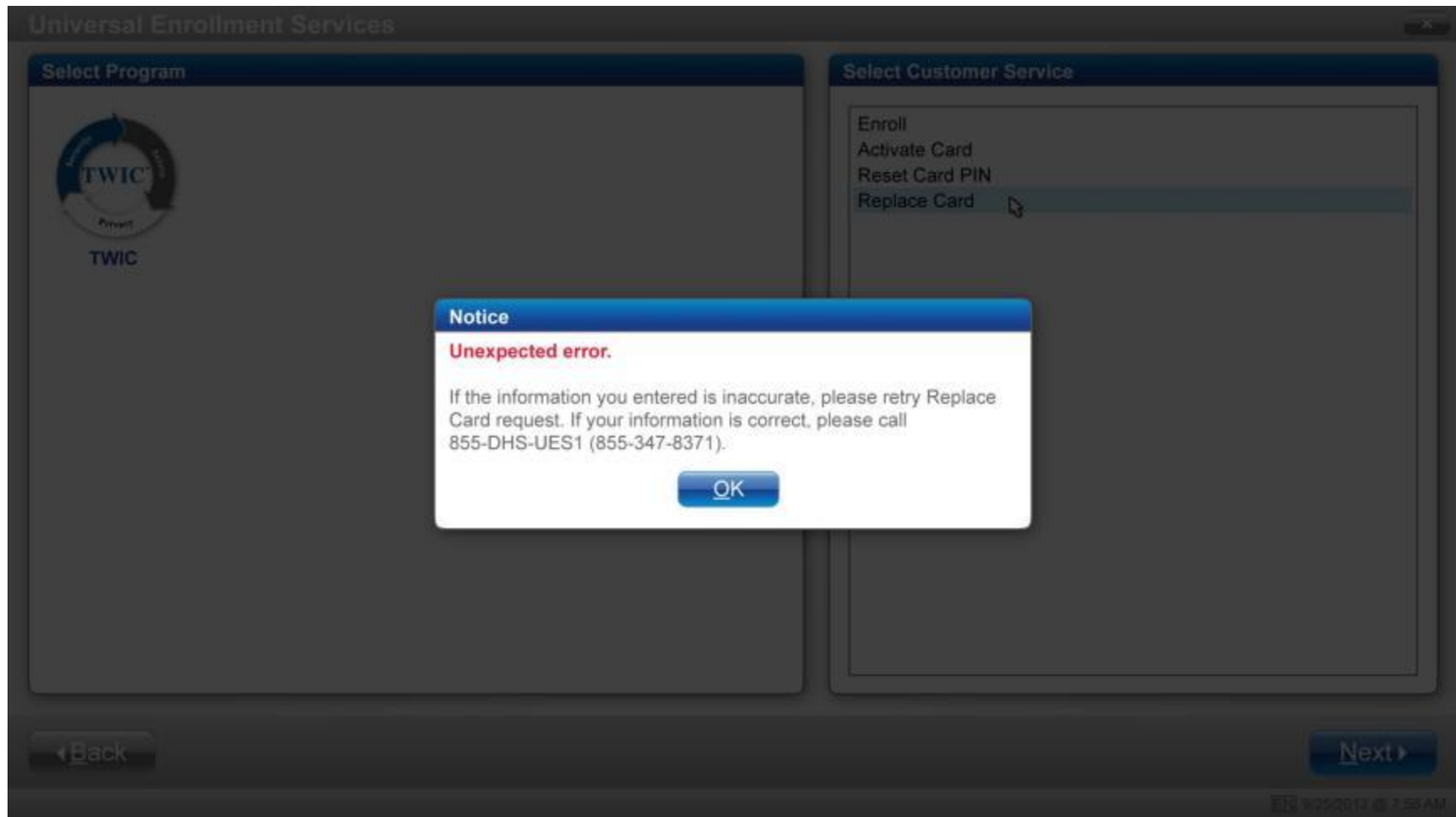
