National School Lunch Program

Through this memorandum, we are requesting a non-substantive change to the burden estimates for the Certification of Compliance with Meal Requirements for the National School Lunch Program, under the Information Collection Request (ICR), OMB Control No. 0584-0567, which was approved on June 20, 2012.

Based on feedback from State agencies and in an effort to reduce burden, Food and Nutrition Service (FNS) Child Nutrition Division will require less information to be provided in the agencies' quarterly report. This change results in a reduction of burden time from an estimated 1 hour per quarterly report to 15 minutes; the program change to reduce the quarterly report requirement will result in a decrease of 168 burden hours.

There are no other changes at this time to this data collection. Below are two charts, the first is what is currently approved in ROCIS and the second chart reflects the revised burden hours for which the program is seeking approval.
