The Federal Pacific Coast Groundfish Regulations (50 CFR §660.140) require vessel accounts to be renewed between October 1 and November 30 each year. All vessel account renewal requests must be completed and submitted online through your vessel account.

If you do not renew your vessel account, or the renewal request is not complete as of November 30, 2012, NMFS will inactivate your vessel account on December 31, 2012. Any QP or IBQ pounds in your vessel account will expire, and surplus QP or IBQ pounds will not be available for carryover. Submission of all required Economic Data Collection (EDC) surveys is mandatory to complete renewals.

You must have Adobe Reader installed to complete your IFQ renewals. Please go to [this website](#) to download Adobe Reader if you do not currently have it.

Information entered as a part of the online renewal will not be saved or submitted until the renewal is certified on the final certification screen. If you open the renewal screen and exit before the final certification, no information will be saved and you will need to start over.

Please note that if you are not the current owner of the vessel listed on the vessel account, you cannot renew the vessel account. You must be the current owner of the vessel to renew the vessel account.

If you also have a quota share (QS) permit and/or other vessel accounts, you must renew each separately by logging into each account. YOU MUST CLOSE YOUR WEB BROWSER BETWEEN EACH RENEWAL.

### Vessel Account Renewal Overview

Each page will have instructions, but here is an overview of what you can expect:

- Verify or edit the vessel owner contact information.
- Review your most recent ownership interest information by opening an Adobe PDF file. If the information presented in the PDF is correct as given, you will need to certify that the information is correct. If the information presented in the PDF is incorrect or incomplete, you will need to certify that the information is incorrect and submit a new notarized ownership interest form by mail postmarked no later than November 30.
- Indicate whether or not your business is a small business after reading the definition of a small business.
- Certify your renewal request.
- Optionally answer questions about how you use this vessel account.
- Remember to close your web browser between each renewal if you intend to renew multiple permits/accounts.

As part of various rulemakings related to the Pacific Coast groundfish fishery, the National Marine Fisheries Service (NMFS) is required to analyze the effect of such regulations. To assist with these Regulatory Impact Reviews (RIR)/Initial Regulatory Flexibility Analysis (IRFA), NMFS must determine if permit and license owners participating in the fishery are big businesses or small businesses as defined by the Small Business Administration.

**Small businesses.** The Small Business Administration has established size criteria for all major industry sectors in the US, including fish harvesting and fish processing businesses.

- **A business involved in fish harvesting** is a small business if it is independently owned and operated and not dominant in its field of operation (including its affiliates) and if it has combined annual receipts not in excess of \$4.0 million for all its affiliated operations worldwide.
- **A seafood processor** is a small business if it is independently owned and operated, not dominant in its field of operation, and employs 500 or fewer persons on a full time, part time, temporary, or other basis, at all its affiliated operations worldwide.
- **A business involved in both the harvesting and processing of seafood products** is a small business if it meets the \$4.0 million criterion for fish harvesting operations.
- **A wholesale business servicing the fishing industry** is a small business if it employs 100 or fewer persons on a full time, part time, temporary, or other basis, at all its affiliated operations worldwide.
- **For marinas and charter/party boats**, a small business is one with annual receipts not in excess of \$7.0 million.

**Small organizations.** The Regulatory Flexibility Act defines **small organizations** as any nonprofit enterprise that is independently owned and operated and is not dominant in its field.

**Small governmental jurisdictions.** The Regulatory Flexibility Act defines **small governmental jurisdictions** as governments of cities, counties, towns, townships, villages, school districts, or special districts with populations of less than 50,000.
