To receive these contributions, the employees must also notify the employer that they have established an HSA.

The information will be used by employers to identify employees who have established an HSA by the appropriate time period and to make HSA contributions to the HSAs of those employees.

Estimated number of respondents is 5 million, estimated annual responses are 1 million and total hours requested is 1,250,000.

Estimates of the annualized cost to respondents for the hour burdens shown are not available at this time.

13. ESTIMATED TOTAL ANNUAL COST BURDEN TO RESPONDENTS

As suggested by OMB, our Federal Register notice dated August 2, 2013, requested public comments on estimates for cost burden that are not captured in the estimates of burden hours, i.e., estimates of capital or start-up costs and costs of operation, maintenance, and purchase of services to provide information. However, we did not receive any

comments from taxpayers on this subject. As a result, estimates of the cost burdens are not available at this time.
