These information collection tools provide a systematic means of monitoring community NFIP compliance. Through the CAC and CAV process and the associated FEMA forms to collect the data, FEMA can also determine to what extent communities are achieving the flood loss reduction objectives of the NFIP. By providing assistance to communities, the CAC and CAV process also serve to enhance FEMA's goals of reducing future flood losses, thereby achieving the cost-containment objective of the NFIP.
