Questions for Single Unit Establishments

2. In 2017, did your establishment outsource, either domestically or internationally, the manufacturing or production of any products or goods?
  1. Yes – go to 3
  2. No – go to 5
  
3. For the products or goods that were outsourced, did your establishment determine the design or specifications?
  - a. Yes – go to 4
  - b. No – go to 5
  
4. What was your establishment's 2017 revenue from the sale of the products or goods that were outsourced?
  - a. \$0-\$X – go to 5 (Note: \$X yet to be determined)
  - b. >\$X – go to next section
  
5. In 2017, was your establishment responsible for the design and manufacture of any products or goods that were manufactured or produced at a different location?
  - a. Yes – go to next section
  - b. No – go to next section

Questions for Establishments part of a Multi Unit

1. In 2017, did your establishment manufacture or produce any products or goods at this location?
  - a. Yes – go to 6
  - b. No – go to 2
  
2. In 2017, did your establishment arrange for any other locations within your company, either domestic or international, to manufacture or produce any products or goods?
  - a. Yes – go to 3
  - b. No – go to 3
  
3. In 2017, did your establishment arrange for any other companies, either domestic or international, to manufacture or produce any products or goods, that is, “outsource”?
  - a. Yes – go to 4
  - b. No – go to 4 (except for also No in 2, they go to 6)
  
4. For the products or goods that were outsourced to {other locations within your company /other companies / other locations within your company or other companies}, did your establishment determine the design or specifications?
  - a. Yes – go to 5
  - b. No – go to 6
  
5. What was your establishment’s 2017 revenue from the sale of the products or goods that were outsourced to {other locations within your company /other companies / other locations within your company or other companies}?
  - a. \$0-\$X – go to 6
  - b. > \$X – go to 7
