## **Introduction**

---

Wildlife TRACS (Tracking and Reporting on Actions for the Conservation of Species) is a geospatial tracking, reporting and decision-support tool that will demonstrate the effectiveness of grants administered by the Wildlife and Sport Fish Restoration (WSFR) Program of the US Fish and Wildlife Service (FWS). TRACS will be used for all grants administered through WSFR and address the needs of policy makers, appropriators and the public to determine the relevant outcomes and performance of the WSFR Program, and provide decision support to the FWS and the States to facilitate strategic and effective investment of public funds in the conservation of species and other mandated uses.



## Need

---

The need for Wildlife TRACS originated from the need to demonstrate to the Congress and to the Office of Management and Budget (OMB) the efficacy of State Wildlife Grants at addressing the needs of Species of Greatest Conservation Need (SGCN). In 2009, the US Fish and Wildlife Service formed a pilot group with representatives from sixteen state fish and wildlife agencies and partner NGOs to develop a new system to track accomplishments of the SWG Program and to indicate the effectiveness of federal expenditures in reversing declines in SGCNs and preventing those species from being listed under the federal Endangered Species Act.

Reporting on accomplishments with WSFR administered funds has traditionally focused on units of outputs such as acres of habitat or miles of stream improved. Although this information is important for conservation practitioners to track progress and efficiencies of projects, how these outputs contribute to desired conservation outcomes have not necessarily been quantified or tracked – or, for that matter, clearly explained. For example, when SWG funds have been used to restore native grasslands, conservationists have inferred from the number of acres restored the benefits to grassland birds. Inference, however, is neither a measurement of improvement for grassland birds nor, more importantly, a quantification of how restored acres of native grassland may have contributed to sustainable populations of grassland birds.

The tracking of outputs has also been traditional for projects funded by Pittman-Robertson (PR) Wildlife Restoration Act and Dingell-Johnson (DJ) Sport Fish Restoration Act grants. Indeed, measures just of output served the conservation community well for decades. Today, things are changing. The recreational shooting, archery, fishing, and boating industries that fund PR and DJ want to know more than just outputs; they also want to know if the outputs are increasing hunter and angler recruitment and retention and if the excise taxes they pay are benefitting their financial bottom lines.

Wildlife TRACS will provide the WSFR program an opportunity to expand tracking and reporting for all WSFR administered grant programs beyond historic output-based accomplishment reports to reports that include performance and outcomes of WSFR-funded fish and wildlife conservation programs.

## Glossary

---

<b>Access Priviledges</b>	Precise statements that define the extent, to which an individual can access computer systems; use the programs and data on a system, and under what circumstances this access will be allowed.
<b>Account</b>	A combination of username and password or other authentication combination which allows access to a system.
<b>Account Management</b>	Involves (1) the process of requesting, access, group and role assignment and deactivating user accounts; (2) tracking users and their respective Access authorizations; and (3) managing these functions.
<b>Action</b>	An action is an intervention undertaken by a project team to reduce threats, capitalize on opportunities, or restore natural species and ecosystems (equivalent to a "strategy" in the CMP Open Standards). An action is user defined and can be represented spatially by polygon(s) on the TRACS mapper. Projects contain one or more actions; and, actions are used as the reporting mechanism for grants.
<b>Activity</b>	A specific descriptor of an action used for very specific reporting needs. This level of detail is optional with some exceptions. For those programs for which this level of detail is required, outputs are also required. Estimated costs are optional at this level.
<b>Approach</b>	A plan to solve a situation or problem that leads to a desired outcome.
<b>Basemap</b>	A map depicting background reference information such as landforms, roads, landmarks, and political boundaries, onto which other thematic information is placed. A basemap is used for locational reference and often includes a geodetic control network as part of its structure.
<b>Bookmarks</b>	A TRACS map tool that enables a user to quickly access frequently used geographic locations.
<b>Bundles</b>	A collection of projects rolled up together in a package for submittal (e.g. projects are grouped into an application bundle before being submitted to WSFR for approval).
<b>Category</b>	A category is a generic descriptor that determines the type of action. This is a pick list in TRACS. Estimated costs are required at this level. Category is used as a basis for aggregating like actions for reporting purposes.
<b>Converted Data</b>	Data from legacy systems or remote databases that has been translated into a structure that is compatible with TRACS.



---

<b>Data Ingestion</b>	The process of consuming data from remote systems in a format that is compatible with TRACS.
<b>Effectiveness Measure</b>	A metric of accomplishment that describes how successfully the objectives of a project are met through the implementation of specific actions (quantitatively or qualitatively). An accomplishment and outcome assessment that quantifies the extent to which a project process produces intended results. The effective measurement process quantifies how well the project provides timely, accurate, and useful information to decision makers.
<b>Expected Results</b>	Describes specifically the expected effects of the completed effort on people or resources.
<b>Indicator</b>	A method of measuring the desired future state of an objective. In particular, TRACS uses indicators to assess whether a given conservation action is leading to a desired objective and ultimate impact. Indicators may be standard (i.e. measurable by action outputs) or custom (i.e. measurable only by the end user via periodic progress reports).
<b>Feature Editor</b>	A TRACS tool allowing the user to create and edit plan, project, and action shapes.
<b>Feature Explorer</b>	A TRACS tool allowing users to view, create, and edit plan, project and action attributes such as properties, cost, objectives, and attachments.
<b>Feature Search</b>	Allows users to search for a plan, project, or action.
<b>Federal Funding Source</b>	Award information from FBMS can only be associated with a project statement by the WFRS grant specialist
<b>Geospatial Data</b>	Information that identifies the specific location and characteristics of natural or constructed features as well as boundaries on the earth.
<b>Grant</b>	An award of financial assistance made by the Federal Government to an eligible grantee allowing fulfillment of one or more approved projects.
<b>Grantee</b>	A person or group to whom a grant is made. Recipients of grant proposals receive funds.
<b>Group Layers</b>	A group is a collection of users assigned to a specific entity. By default, Data TRACS has top-level groups that correspond to state and federal Agencies. A top-level group can have one or more sub-groups that correspond to state fish and wildlife agencies or regional offices. A sub-group can have one or more-sub groups of its own that correspond to regional boundaries, departments, jurisdictions, or areas of responsibility. The workload associated with user management necessarily increase as



more-sub-groups are defined.

Data TRACS users participate in one or more groups and are assigned one or more roles that pertain to one or more entities. For example:

User: John Doe  
 Group: Washington Department of Fish and Game  
 Role: State Editor  
 Entity: Project

Additional spatial datasets that are superimposed onto a base map.

<b>Map</b>	A graphical representation of the spatial relationships of entities within an area.
<b>Map Legend</b>	Allows users to view symbology information for all visible features on a map (e.g. figures, shapes, lines and places).
<b>Multipurpose Project</b>	A grant-funded project that carries out the purpose of a single grant program and also carries out either the purpose of another grant program, or an activity unrelated to a grant.
<b>Need Statement</b>	A statement that describes a specific problem and cites research or data to support the description.
<b>Objective</b>	The specific and measurable desired future state of the purpose or target (e.g. “decrease the number of hunting accidents” or “increase the population of species x by 30%). Objectives consist of specific statements of what exactly will be accomplished by a plan, project, or action. Objectives may be expressed as a quantity, a deadline, and/or the required quality of accomplishment.
<b>Output Measure</b>	A metric of accomplishment quantifying the amount of work, activity, or production completed by a group of practitioners during a given time frame.
<b>Plan</b>	A defined and accepted strategy for achieving specific goals within a defined geographic region. Plans are optional in TRACS, but they are helpful to show linkages between work and strategic planning efforts.
<b>Polygon</b>	A flat shape consisting of straight lines that are joined to define the borders of a project.
<b>Project</b>	A user defined boundary in which a set of actions and/or activities are performed by a team of practitioners to achieve specific goals and objectives.




**Project Narrative** A description that highlights the project’s benefits, purpose, species, and implementation techniques and, is used internally and externally.

**Project Description** A narrative that highlights the project’s purpose, benefits, impacts, and implementation techniques and, is available internally and externally.

**Purpose/Target** The intended outcome of a project in general terms.

**Role** A role is the permissions that are associated with a particular user function or operation.

**Symbols**

	Indicates the field is required
	Description of the field
	Information is display in public reports

**Strategy** A specific descriptor that can be used to generate more specific aggregations for reporting purposes. This is a pick list in TRACS. Estimated costs are options at this level; output measures are required.

**Threat** A negative force or pressure acting upon a specific resource and requiring a specific response.

**TRACS User** Includes user profiles, groups, permissions, etc.

**Need** The lack of something that is wanted or deemed necessary as it relates to a specific resource.

**Vertice** Polygon points that segment polygon lines; multiple points are called *vertices* or corners. Vertices can be used as handles to move and adjust a polygon’s lines.

**Wildlife TRACS** Tracking and Reporting Actions for Conservation of Species (TRACS). TRACS is an online data management tool to facilitate WSFR tracking and reporting accomplishments related to federal assistance grants. It is comprised of two parts: Data TRACS and State TRACS.

**Workflow** A set of tasks carried out in a certain order to achieve a goal.

## **Chapter 1 – User Management**

---

### **Guidelines**

---

Account Establishment and Duration. Each Account shall be for the individual use of an identified user. Accounts remain valid for the duration the individual maintains the relevant status with the U.S. Fish and Wildlife Service or state agency or until the account is deactivated.

Each user must have a unique identifier and to be successfully authenticated to gain access.

Records of processed and denied requests for the creation and/or modification of user accounts will be kept for auditing purposes. Records will be retained for one year.

The creation of a user account must be initiated through an on-line request form and be authorized by pertinent levels of management.

If a user is servicing multiple offices, a separate Wildlife TRACS User Access Request must be authorized by their supervisor and submitted for each individual office.

To retain an “Active” status on your Wildlife TRACS account simply log into the Wildlife TRACS application system every 60 days. Infrequent users are responsible for keeping their user account with an “Active” status.



---

## Access Procedures Frequently Asked Questions

### Who should use Data TRACS?

Persons responsible for inputting or managing WSFR grant program projects and performance data, especially state wildlife agency coordinators, program specialists, project leaders, and WSFR grant specialists.

### Who should approve new user requests?

New user requests are approved by the User Administrator for the office or agency to which the user belongs. The User Administrator is informed of new user requests via email and is responsible for approving or denying access within a reasonable time frame. User Administrators are responsible for verifying the accuracy and validity of new user requests prior to approval.

The TRACS Help Desk via [tracs-helpdesk@fws.gov](mailto:tracs-helpdesk@fws.gov) can assist offices with the initial registration of User Administrators.

### What happens when an employee no longer requires access?

TRACS User are responsible for deactivating end-user accounts when access is no longer needed. End-user passwords expire every 60 days as a security measure. Regional office and state agencies should review all system accounts and privileges on an annual basis.

### What is a role?

A role is the permission associated with a particular user function or operation. Data TRACS defines the following roles:

**Account Holder:** The individual which is assigned an account.

**User Administrator:** Individual who is responsible for administering user access requests, group and role assignments, and account deactivation.

**State Editor:** Responsible for entry of specific data elements (e.g. plans, projects, actions).

**State Review:** Responsible for review of system outputs and reports.

**State Approver:** Responsible for approval of system outputs and reports.

**Federal Reviewer:** Responsible for review of system outputs and reports.

**Federal Approver:** Responsible for approval of system outputs and reports.



---

## What is a group?

A group is a collection of users assigned to a specific entity. By default, Data TRACS has top-level groups that correspond to state and federal agencies. A top-level group can have one or more sub-groups that correspond to state agencies or regional offices. A sub-group can have one or more sub-groups of its own that correspond to regional boundaries, departments, jurisdictions, or areas of responsibility. The workload associated with user management necessarily increases as more sub-groups are defined within a parent group.

## How are permissions handled in Data TRACS?

Permissions in Data TRACS are group based. State and Federal agencies are assigned a top-level group (e.g., Group = Montana; Group = Department of the Interior). Within each top-level group, sub-groups are created to correspond to state fish and wildlife agencies, Federal bureaus, and regional offices. Sub-groups can have additional sub-groups to accommodate various office, departmental, or jurisdictional organization schemes.

End-users belong to one or more groups and have specific permissions (i.e. the operations or functions the user can perform). Permissions are inherited in a top-down hierarchy. For example, a user with permission to edit project data in the Department of Interior (DOI) group automatically has permission to edit project data in the U.S. Fish & Wildlife Service (USFWS) group. However, a user who is in the USFWS group *does not* have implicit permission to edit data in the DOI group. It is important to keep track of which end-users belong to a specific group in order to ensure that unintended access is not available through group inheritance. Data TRACS will include user management tools that display group participation and end-user permissions.

Federal end-users of Data TRACS are managed by the appropriate regional WSFR office. Management of state, tribal, and territorial users is the responsibility of the appropriate State agency. State agencies will identify one or more User Administrators during the registration process who are responsible for approving, managing, and deactivating end-user accounts at the appropriate level.

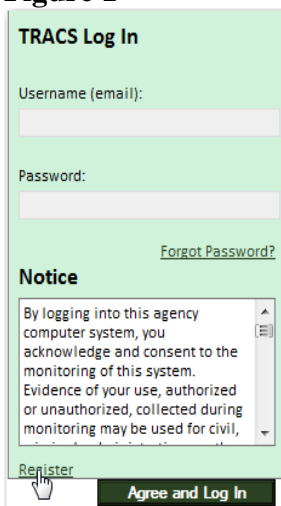

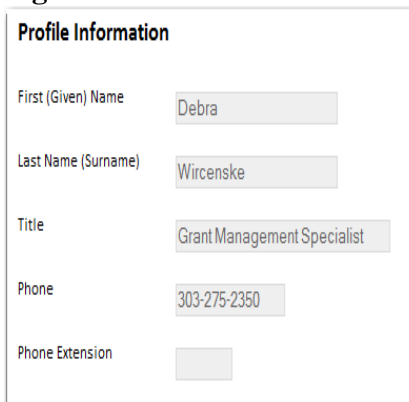

Data TRACS will use your e-mail address as your username; therefore, if your e-mail changes you should register for a new access account and your old account will be disabled.

**Hint:** Your password should be a minimum of 12 characters with a combination of lower, upper case and contain one non alphanumeric character such as #@. Numeric numbers are optional. Passwords should change by at least two characters. Passwords cannot be re-used within 365 calendar days.

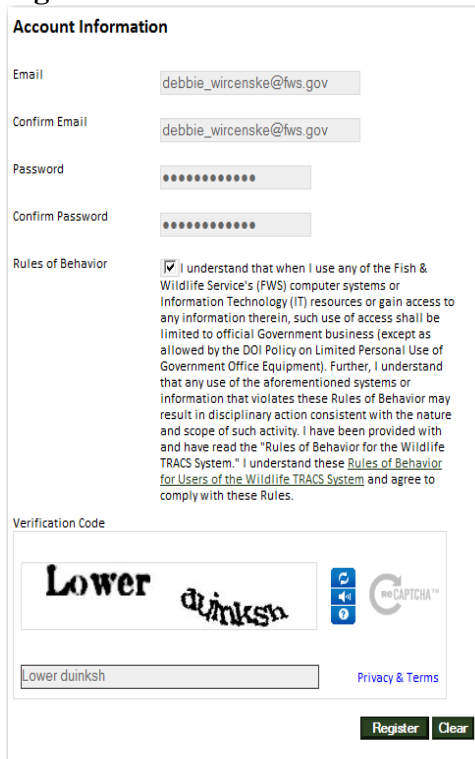
**Note:** Change your password if you believe it has been compromised and report the incident to the Wildlife TRACS Help Desk at [tracs-helpdesk@fws.gov](mailto:tracs-helpdesk@fws.gov). If a user account name and password are keyed in five (5) consecutive times without correctly accessing the system, the account will be automatically locked for 15 minutes.


**Tips and Hints**

**Strong Password**

TRACS requires the use of strong passwords. A strong password has:

- A minimum of 12 characters.
- At least one lower case letter.
- At least one upper case character.
- At least one non alphanumeric character, such as #, \* % !, etc.

## **Role and Group Assignment**

---

The Approve Access Request form allows the User Administrator to assign or change role(s) and groups for the requesting user.

The “Requested Role” is the default role assigned to the requesting user. The default role is identified from the Agency Type selected by the requesting user when registering for access to Data TRACS. The default role for users associated with a Federal agency is Federal Reviewer. The default role for users associated with a State or Tribal agency is State Editor.

- The Editor role enables a requesting user to create and edit plans, projects, and actions within their group assignment and initiate workflow actions.
- The Reviewer role enables a requesting user to create and edit plans, projects and actions within their group assignment and complete reviewer functions in the workflow.
- The Federal and State Approval role enables a requesting user to create and edit plans, projects and actions within their group assignment and complete approval functions in the workflow.

A group is a collection of users assigned to a specific group or subgroup. By default, Data TRACS has top-level groups that correspond to state and federal agencies. A top-level group can have one or more sub-groups that correspond to state fish and wildlife agencies or regional offices. A sub-group can have one or more sub-groups of its own that correspond to regional boundaries, departments, jurisdictions, or areas of responsibility.

**Federal:** In this example, a user is assigned to a Federal Agency, U.S. Fish and Wildlife Service, Headquarters (subgroup of U.S. Fish and Wildlife Service), Division of Ecological Services (subgroup of Headquarters). The Federal Reviewer role is assigned by default.

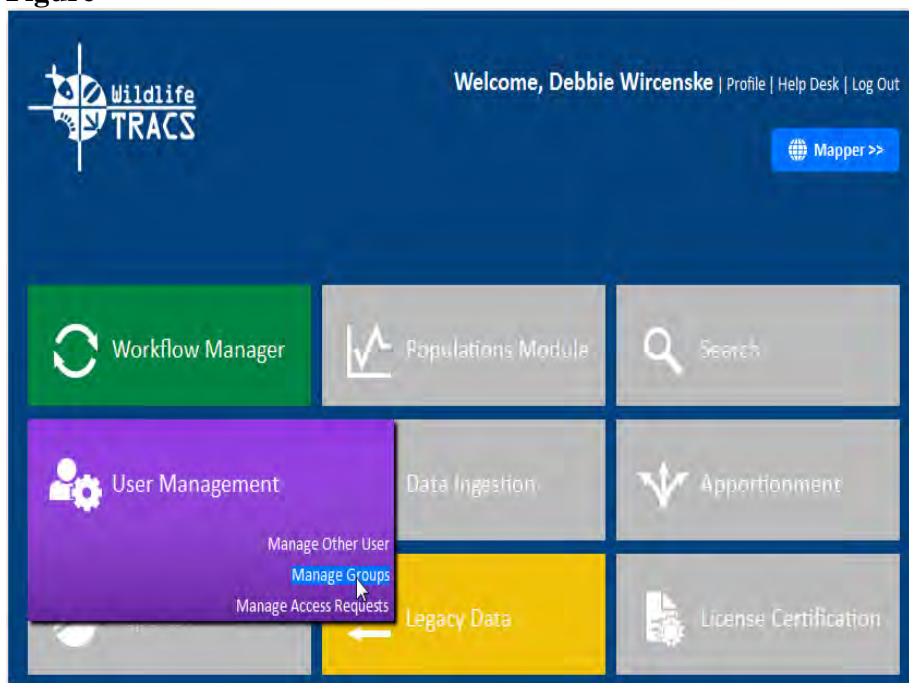

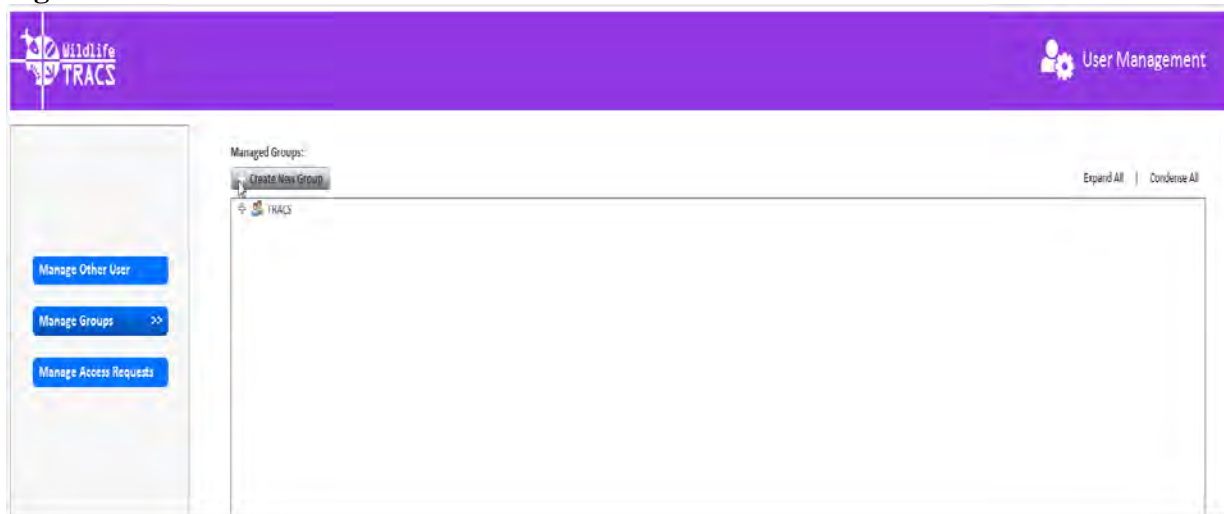


**(Figure 1)**

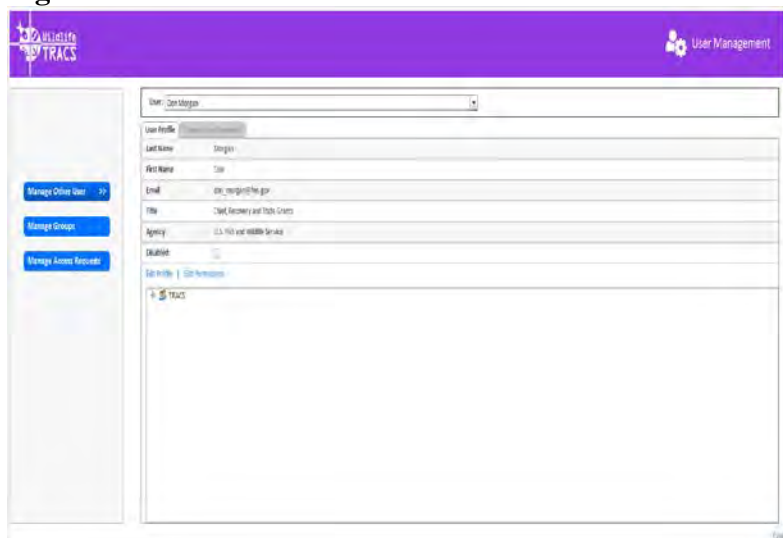


**(Figure 1)**

## Chapter 2 – Dashboard and Mapper

---

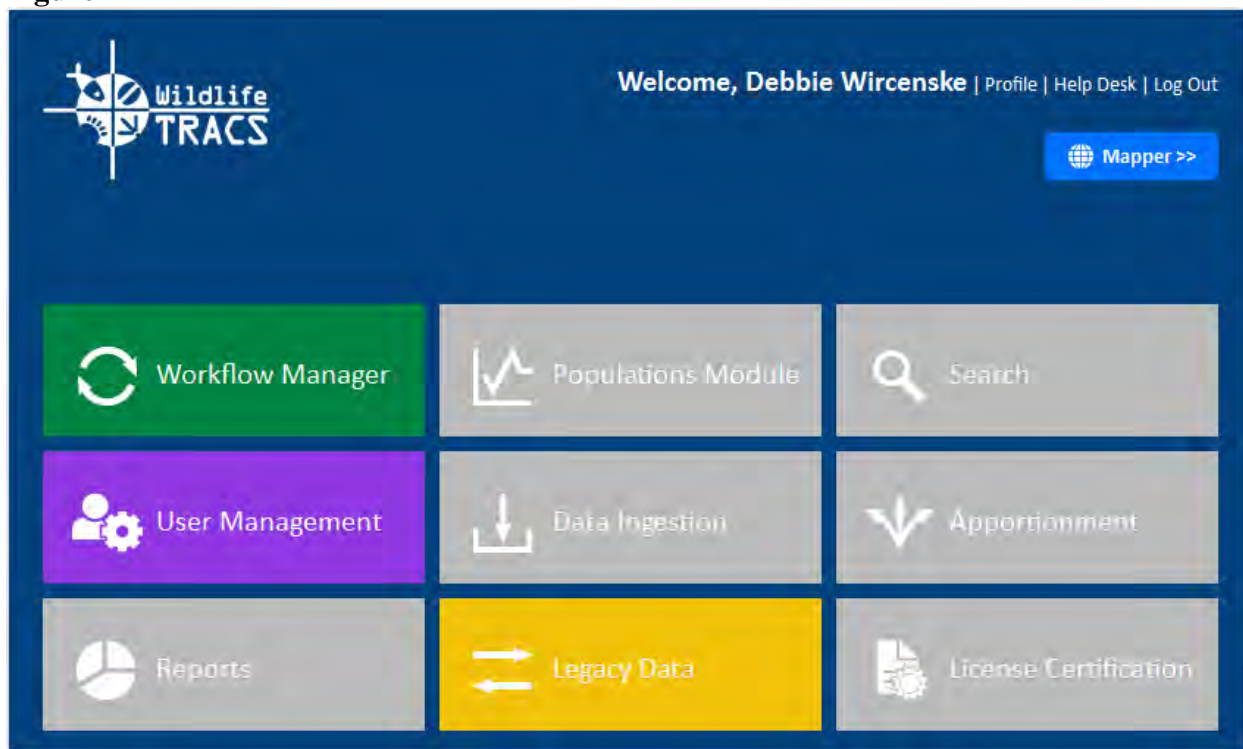
The Wildlife TRACS dashboard is a central point of access to the Data TRACS application. The Wildlife TRACS dashboard consists of modules, tools, reports and functions.

Users who have successfully logged into DataTRACS will be directed to the Wildlife TRACS dashboard.

Users will notice that some of the Data TRACS application modules are temporarily greyed out. The greyed out modules are in the development phase and will be made available to users as they are completed.

The Data TRACS modules currently available to users include Workflow, User Management, and Legacy Data.

The Workflow Manager allows Wildlife TRACS users to view and manage the status of their project(s) within the project or grant lifecycle.

User Management allows User Administrators the ability to approve access requests for Data TRACS, edit and create user groups, and assign roles and permissions.

Legacy Data allows WSFR Wildlife TRACS users to view and manage legacy records from the Federal Aid Information System (FAIMS).

Located in the upper right hand of the Wildlife TRACS dashboard are links that include Profile, Help Desk, and Log Out.

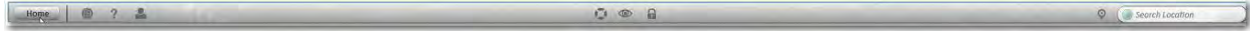

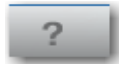

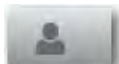

Displays a list of available basemaps in Wildlife TRACS. The Bing Hybrid map is visible by default. Basemaps are used to display specific location by features and characteristics. For example, a road basemap reflects the features (small-scale) and characteristics of roads for a specific location. A topographic basemap reflects the features (large-scale) and characteristics present at a specific geographic location (e.g. elevation).



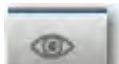
Help Desk. End-users can submit a Help Desk request to the TRACS support team.

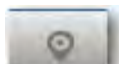

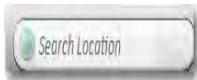

The components of the Navigation tools are listed below with a brief description



Pan mode allows end-users the ability to grab and move the map in any direction by left clicking on the map.



Zoom In allows end-users to zoom in on a particular map area by drawing a box.



Zoom Out allows end-users to zoom out on the map by drawing a box.



Show Map Scale allows end-users to toggle the map scale located at the center bottom of the basemap.



Show Mouse Coordinates displays the latitude/longitude at the end-user's mouse cursor location.



Show Overview Map allows end-users to view a world street map superimposed on the current basemap. This is useful for determining street location when viewing satellite imagery.

Feature Search allows end-users to search for existing plans, project, or actions. Searches can be performed using the feature name or ID number.

## Layer Manager Tool

Restore Dock opens or closes the dock.



Layer Manager allows end-users to control the visibility of reference layers (e.g. external datasets and TRACS features) on the mapper.

**Note: Reference layers can assist with creating features like plans, projects, and actions.**



Bookmarks allows end-users to bookmark geographic locations for quick reference in the future (e.g. project location, region, state, county). Bookmarks are specific to a individual user account but can be shared.



Map Legend allows end-users to view symbology and labels for reference layers and TRACS features. Specific colors and shapes are used to identify items of interest (e.g. habitat types).

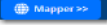

## Chapter 3- Plan

---

### Frequently Asked Questions

---

#### What is a Plan?

A Plan is a defined and accepted strategy for achieving specific goals within a defined geographic region. Plans are optional in TRACS. Plans allow end-users to establish linkages between strategic planning objectives and projects implemented.

#### Can Plan objectives be inherited by Projects?

Plan objectives can be inherited by projects. Under Project Statement Objectives, the "Inherit from Plan" button allow end-users to choose a plan and objectives to inherit.

#### Who should enter Plan information for a Federal or inter-state plan?

It is highly recommended that a WSFR staff member enter information from a federal or inter-state Plan for maximum efficiency. The exception is if a State wants to inherit specific objectives pertinent to their project(s). In this scenario, it is helpful for the State to enter the Plan objectives even though more general information for the Plan may have been entered into Data TRACS by someone else.

**Note:** Specific TRACS features should be set to visible using the Layer Manager prior to creating a plan, project, or action. Plans are NOT visible by default and should be toggled to visible prior to defining a new Plan.

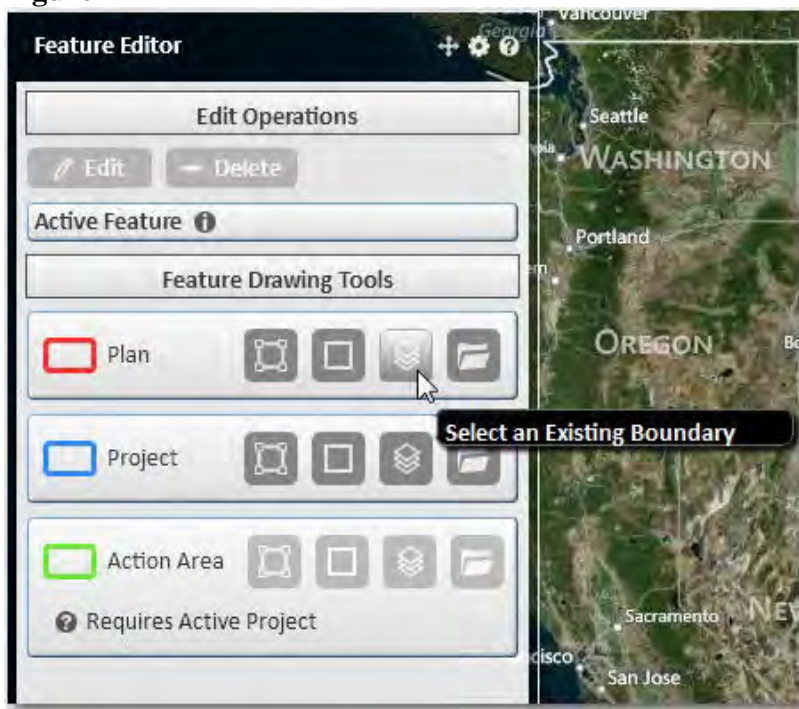

### Hints: Feature Drawing Tools



The Freehand Polygon allows end-users to capture specific location areas which are contoured. e.g., habitat area, forested area. Freehand Polygon is created by holding down the left mouse button and moving the cursor until the desired polygon is visible and then releasing the left mouse button.



**Geometric Polygon** allows end-users to capture specific location areas which are linear (point-to-point). Geometric Polygon areas are created by left clicking the mouse of the map to a single vertex. Continue clicking the left mouse button at each vertice of change in direction until the desired polygon is visible. Double click the left mouse button to complete the feature.

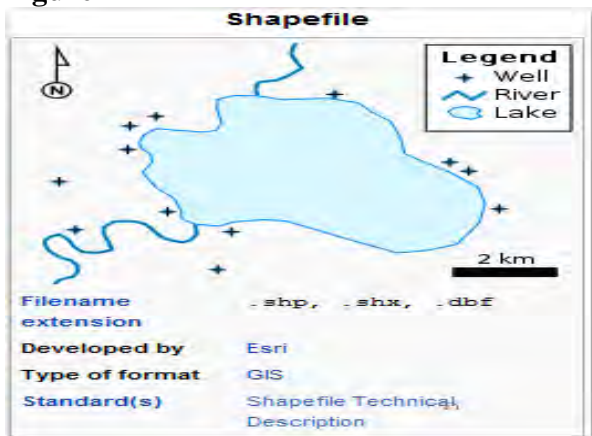


**Select an Existing Boundary** allows end-users to capture specific location areas which have pre-determined boundary types. e.g, States, Counties, Congressional Districts. Select this tool if a plan and project is Statewide or for a specific County.



**Import Shape Files** allows end-users to import shape files from a local source. A shape file contains spatial features which represent a specific type of location. e.g., rivers and lakes.

## **Chapter 4 - Project**

---

### **Frequently Asked Questions**

---

#### **What is a Project?**

A Project is user defined to describe one or more related actions undertaken by a group of practitioners to achieve specific goals and objectives. A Project is geographically represented by a point and polygon(s) independent of scale and can be related to both parent and/or child projects. Associated data include fields required by WSFR grant program regulations including: goals, objectives, needs, results or benefits expected, approach, estimated costs, etc.

#### **How does a Project relate to a Plan?**

Projects can be nested under Plans and inherit objectives from a Plan.

#### **Can Projects be related to other Projects?**

Yes. In the properties box under a Project there is a tab called "Related Projects". You can easily search for Parent Projects or just Related Projects that are funded by WSFR grants and have been entered into Data TRACS. Other non-WSFR funded projects that may have been entered into State TRACS would not be available through this vehicle.

#### **What are the benefits of relating Projects to other Projects in TRACS?**

There are natural resource conservation and management efficiencies afforded by identifying relationships among Projects. It can help in identifying species and habitats that are receiving sufficient or insufficient attention across larger landscapes. TRACS will have the ability to include hyperlinks that users can employ to easily investigate related Projects.

#### **Is a Project required?**

Yes, just as it is stated in 50 CFR 80.82. A Project is the basis for entering data into TRACS.

#### **How does a Project relate to a Grant?**

Projects are related to Grants as they are now. There could be one project under a Grant or many projects under a Grant. The Project(s) inherit the funding source(s) identified at the grant level and are active within the starting and ending dates of the grant.

#### **Can a Project be funded by more than one Grant or Grant Program?**



Yes. TRACS has the capability to identify multiple funding sources for a Project. These funding sources could be from different Grants or from different Grant programs within the same Grant.

**Is there a limit on the size of a Project?**

There is no limit on the geographic size of a Project. It could be an entire state or multiple states.

**Is there a limit on the duration of a Project?**

Many Projects have a defined duration needed to achieve specific objectives (e.g., three years). Other Projects that are conducted as part of a fish and wildlife management plan should adopt that Plan duration (e.g., perhaps six years). However, for Projects intended to continue indefinitely (e.g., basic hunter education or fish population monitoring) the recommended maximum duration is five years to afford greater ease of use in the system.

**When in the grants process is Project information entered?**

Project information is added when you are writing your grant proposals. TRACS includes a grant application report that contains all Project information needed for the grant which includes:

- a map (i.e., the polygon you created to add a project into TRACS);
- the information in the project statement that includes the typical narrative requirements found in 50 CFR 80.82;
- objectives found in the project statement; and
- attachments if added

**Can a Project be copied and edited to create a second Project?**

Yes.

**Can two different Projects in TRACS have the same name?**

Yes. This will be important as WSFR work that continues year-after-year is documented in TRACS as Projects with defined, instead of infinite, time periods.

**What are best practices for structuring a grant as Project(s) and Actions(s) in TRACS?**

There are a variety of ways for structuring grants as Project(s) in TRACS. This will be part of the WSFR and state training on TRACS. A template has been developed to assist in diagramming this out prior to data entry. In general, grantees should consider a structure that will provide them with the most information, yet be efficient for performance reporting. Consider lumping instead of splitting. For example, if a species restoration project



includes a monitoring component, it is not necessary to have monitoring as a separate Action. The major Action is species restoration.

## Chapter 8-Actions

---

### Frequently Asked Questions

---

#### What is an Action?

An Action is an intervention undertaken by a project team to reduce threats, capitalize on opportunities, or restore natural species and ecosystems (equivalent to a "strategy" in the CMP Open Standards). Actions occur within a Project and are used as the reporting mechanism for grants. Known Action information can be added when writing the grant proposal but is optional until required for performance reports.

An Action is user defined and can be represented spatially by a polygon(s) independent of scale. An action is also described by Category, Strategy, and sometimes Activity.

- A Category is a generic descriptor that determines the type of action. This is a pick list in TRACS. Estimated costs are required at this level. This is used as a basis for aggregating like actions for reporting purposes.
- A Strategy is a more specific descriptor that can be used to generate more specific aggregations for reporting purposes. This is a pick list in TRACS. Estimated costs are optional at this level; output measures are required.
- An Activity is a specific descriptor intended for very specific reporting needs. This level of detail is optional for all programs except Boating Access and Hunter Education. For programs for which this level of detail is required, outputs are also required. Estimated costs are optional at this level.

#### How does an Action relate to a Project?

Actions are the actual work that happens under a project. Information on Actions will be used as the reporting mechanism for Projects and Grants.

#### Is an Action required?

Yes, at least one Action is required per project. Again, this is the reporting mechanism for Projects and Grants.

#### What is the duration of an Action?

The recommended duration for an Action is one year or whatever time period that matches the grant interim or final performance reporting period.

#### Can an Action cover a multi-year period?



Yes. Since it is possible to report on interim measures in Data TRACS, it is possible that an Action can span a multi-year period.

**Can an Action be repeated?**

Yes. An Action can be copied and repeated in another year.

**When in the grants process is Action information entered?**

Action information can be entered when project information is entered for the grant proposal, but is not necessary. Typically, Action information will be entered for reporting purposes after each year of accomplishments.

**Can an Action be copied and edited to create a second Action?**

Yes.

**Can information from a Project be copied and edited to create an Action, particularly for a Project with just one Action?**

Yes. Several types of information can be copied from the Project to create an Action, including the Project polygon and Contacts.

**What are best practices for structuring Action(s) in TRACS?**

There are a variety of ways for structuring Action(s) under a Project. Examples from different grant programs will be included in the Grant Translation Examples portion of this procedures manual.

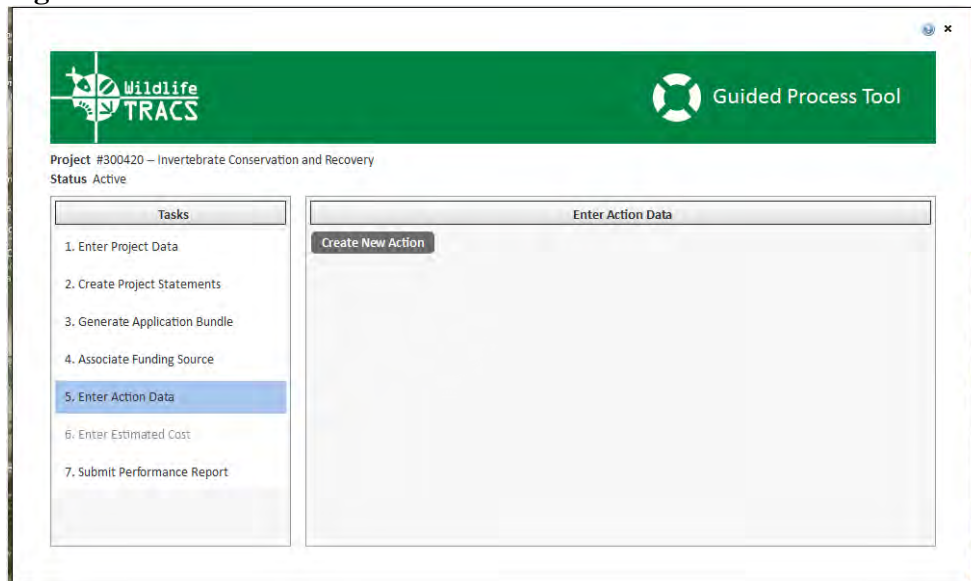

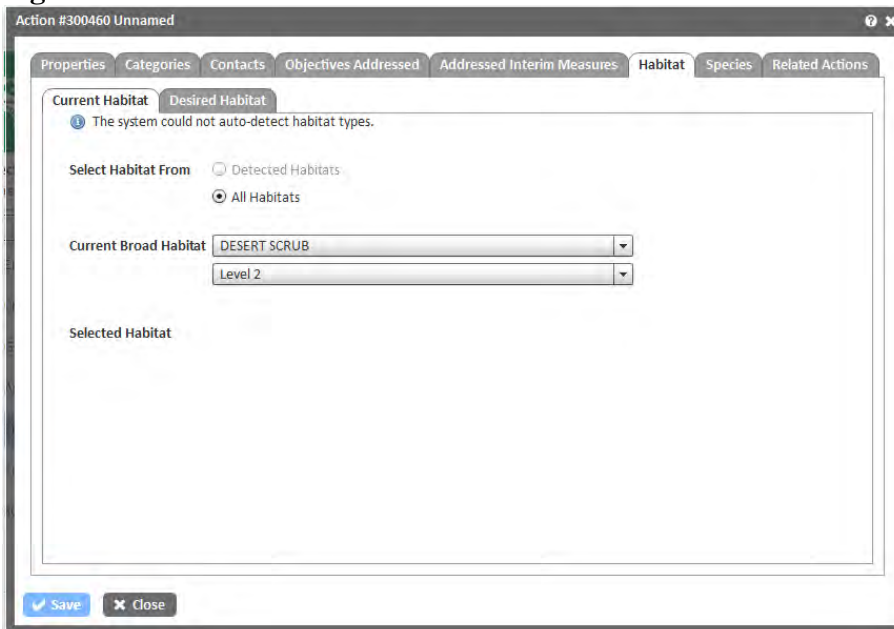

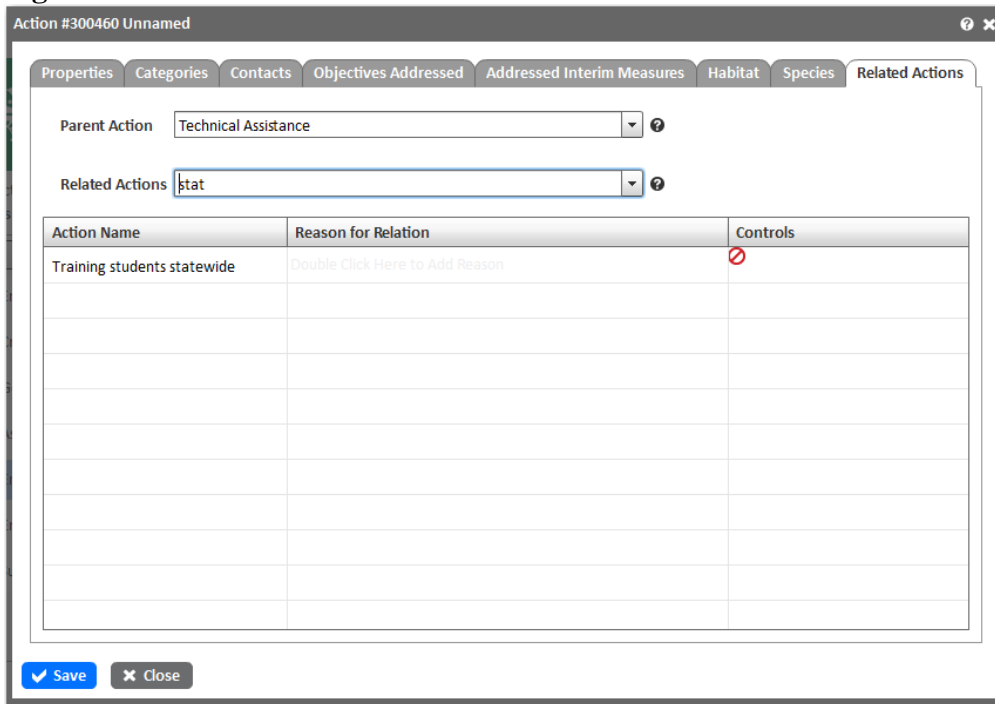

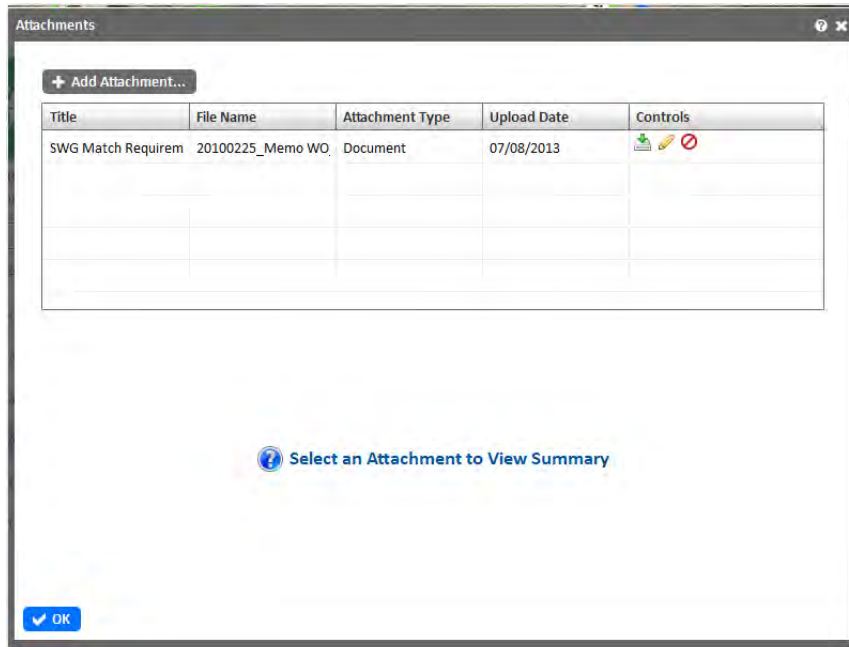

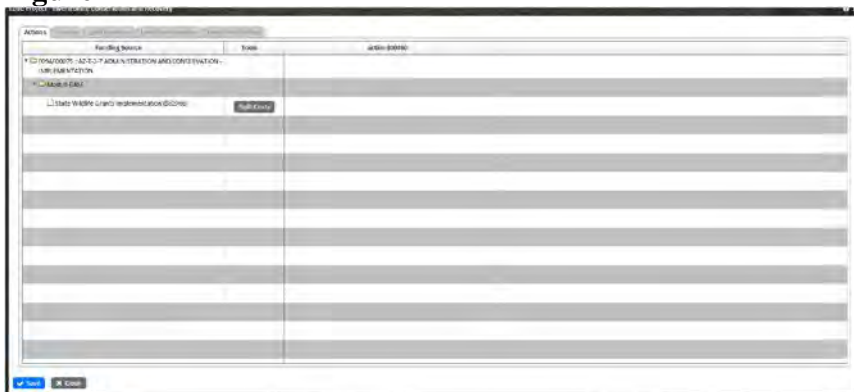

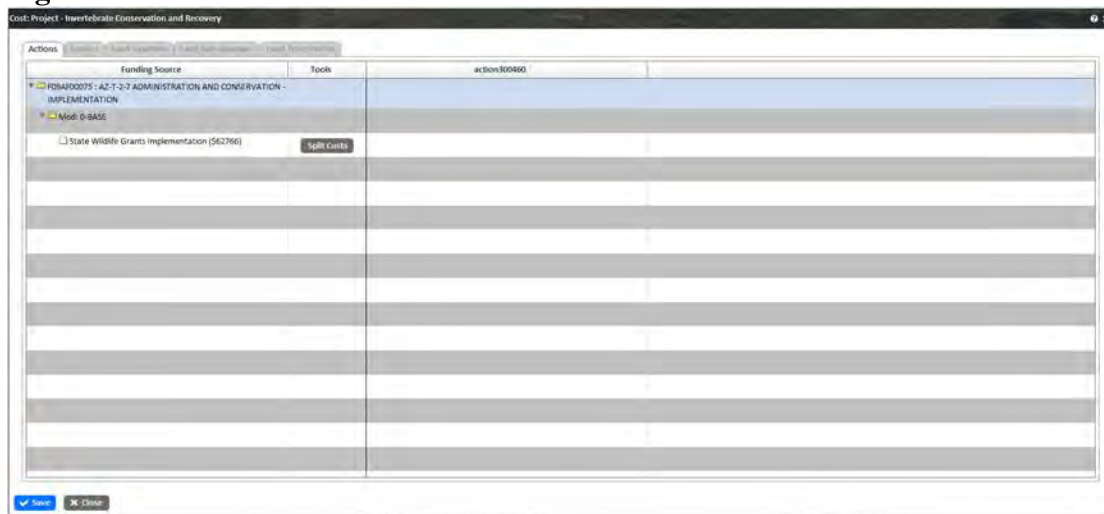
