Are you wanting info on a primary if a dependent is applying for a benefit? If an H-4 is applying for COS are you wanting the H-1B's passport info? Is there a better way to clarify what you are asking and in what circumstances? Maybe clarify, if you have a dependent status (e.g. H-4 or F-2); please provide the Principal's passport info	Lynne Vanahill University of Kansas	Thank you for your insightful comment. The passport number under part 1 (question 11b) is the principal applicant's passport number at the time that they were granted the I-94. The passport number in part 4 is for their current passport. There will be cases where the two numbers will not be the same (e.g., if the applicant received a new passport during their current stay). USCIS has made edits to the form instructions to provide greater clarity on this requirement.

ALL nonimmigrants that have a visa have a date-specific visa and a visa has nothing to do with how long an individual can stay in the U.S. Please refer to 22 CFR 411.112(a) which says "the period of visa validity has no relation to the period of time the immigration authorities may authorize the alien to stay in the United States."
