(g, h, i)</p>	<p>(g) <i>Information.</i> The grantee must provide, upon request of the Secretary, information, including records maintained under paragraphs (e) and (f) of this section, that is necessary to carry out the Secretary’s functions under this part.</p> <p>(h) <i>Records.</i> The grantee must maintain the information under this section related to a scholar for a period of time equal to the time required to fulfill the obligation under paragraph (b) of this section.</p> <p>(i) <i>Notification.</i> The grantee must inform the Secretary if a scholar fails to fulfill or chooses not to fulfill the obligation under paragraph (b)(1) or (b)(3) of this section.</p>	120	20 (1 hour per each of 20 scholars)	2,400	\$60,000
