## Supporting Statement for Paperwork Reduction Act Submissions

### A. Justification

The Appalachia Economic Development Initiative is a collaborative effort among three federal agencies - the Department of Housing and Urban Development (HUD), the Department of the Treasury - Community Development Financial Institutions Fund (CDFI Fund) and the Department of Agriculture - Rural Development (USDA-RD). The purpose of the Appalachia Economic Development Initiative (AEDI) is to support local rural nonprofits and Federally Recognized Indian tribes serving the Appalachian Region for lending and investing activities in businesses lending and economic development, and for securing additional sources of public and private capital for these activities. Funding for the AEDI is provided by recaptured funds from the Rural Housing and Economic Development grant which is authorized by the Department of Veterans Affairs and the Department of Housing and Urban Development and Independent Agencies Appropriations Act, 1998 (Public Law 105-276, October 27, 1997).

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

First, the information collected through the annual one-time application is essential so that HUD staff may determine the eligibility, qualification, and capability of applicants to implement HUD's The Appalachia Economic Development Initiative (AEDI) purpose. Second, AEDI grantees must establish and maintain records to allow HUD to determine whether or not programs are being carried out in accordance with applicable laws and requirements and to facilitate the review and audit of grant management. This is a new collection. The instruments to be used are:

Since FY2005, HUD has required applicants to submit applications electronically through Grants.gov. Data such as semi-annual reports will continue to be submitted in paper form.

No duplication of efforts is caused by this collection.

The collection of information does not adversely impact small businesses or other small entities. Applicants must be local rural nonprofits or federally recognized Indian tribes.

Under the HUD Reform Act of 1989, discretionary funds must be awarded on a competitive basis. Without collecting this information funds could not be awarded.

This information collection was announced in the Federal Register, Vol 78, Page 71635, on November 29, 2013. In response to the Proposed Information Collection HUD received no comments.

Information collection does not involve any payments or gifts to respondents other than renumeration of contractor or grantee.

Estimated Burden

Annualized Cost @ \$25/hr: \$12,550

Explanation of burden hours: Number of responses is based on number of eligible applicants under the AEDI proposed guidelines. The number of burden hours is based on information gathered from RHED applicants. Application requirements and semi-annual reporting requirements for the AEDI are modeled after the requirements of the RHED program. Applicants estimated the application process takes between 80 to 120 hours total and the semi-annual reporting process takes 3 hours.
