ACP & AANP Screening Guidelines

AANP recruits participants through their Conference Registrant Newsletters. Screening criteria are either incorporated in recruitment messaging or as a formal screener questionnaire linked in the focus group invitation.

Both AANP and ACP participants will be screened based on the following criteria:

1. Gender

[QUOTA: recruit representative mix. For groups 2 & 4 over-recruit female participants since a higher proportion prescribe OCPs]

2. Age [QUOTA: 35-65 years]

3. US vs International Medical Graduate **[QUOTA: recruit a representative mix.]**

- 4. Member class
 - Member
 - Fellow
 - Master of the College

[QUOTA: recruit Members and Fellows. Masters do not see patients.]

5. Primary specialty.

[QUOTA: recruit Internal Medicine for broadest prescribing base.]

6. Employer size

[QUOTA: over-recruit community practice as large institutions typically have workflows and other factors influencing prescribing strategies.]

7. Primary practice site

[QUOTA: recruit clinic practice for participants who prescribe regularly.]

[QUOTA: recruit 50-74% and 75% participants.]

- **9.** Location of patient care (inpatient vs. outpatient) [QUOTA: recruit outpatient.]
