GENERAL PROGRAMMER INSTRUCTIONS:

WHEN PROGRAMMING INSTRUMENTS, VALIDATE FIELD LENGTHS AND TYPES AGAINST THE MDES TO ENSURE DATA COLLECTION RESPONSES DO NOT EXCEED THOSE OF THE MDES. SOME GENERAL ITEM LIMITS USED ARE AS FOLLOWS:

Instrument Guidelines for Participant and Respondent IDs:

PRENATALLY, THE **P_ID** IN THE MDES HEADER IS THAT OF THE PARTICIPANT (E.G. THE NON-PREGNANT WOMAN, PREGNANT WOMAN, OR THE FATHER).

POSTNATALLY, A RESPONDENT ID WILL BE USED IN ADDITION TO THE PARTICIPANT ID BECAUSE SOMEBODY OTHER THAN THE PARTICIPANT MAY BE COMPLETING THE INTERVIEW. FOR EXAMPLE, THE PARTICIPANT MAY BE THE CHILD AND THE RESPONDENT MAY BE THE MOTHER, FATHER, OR ANOTHER CAREGIVER.

THEREFORE, MDES VERSION 2.2 AND ALL FUTURE VERSIONS CONTAIN A **R_P_ID** (RESPONDENT PARTICIPANT ID) HEADER FIELD FOR EACH POST-BIRTH INSTRUMENT. THIS WILL ALLOW ROCs TO INDICATE WHETHER THE RESPONDENT IS SOMEBODY OTHER THAN THE PARTICIPANT ABOUT WHOM THE QUESTIONS ARE BEING ASKED.

A REMINDER:

ALL RESPONDENTS MUST BE CONSENTED AND HAVE RECORDS IN THE PERSON, PARTICIPANT, PARTICIPANT_CONSENT AND LINK_PERSON_PARTICIPANT TABLES, WHICH CAN BE PRELOADED INTO EACH INSTRUMENT. ADDITIONALLY, IN POST-BIRTH QUESTIONNAIRES WHERE THERE IS THE ABILITY TO LOOP THROUGH A SET OF QUESTIONS FOR MULTIPLE CHILDREN, IT IS IMPORTANT TO CAPTURE AND STORE THE CORRECT CHILD **P_ID** ALONG WITH THE LOOP INFORMATION. IN THE MDES VARIABLE LABEL/DEFINITION COLUMN, THIS IS INDICATED AS FOLLOWS: **EXTERNAL IDENTIFIER: PARTICIPANT ID FOR CHILD DETAIL.**

PROGRAMMER INSTRUCTIONS

- INSERT DATE/TIME STAMP
- PRELOAD PARTICIPANT ID (**P_ID**) FOR CHILD AND RESPONDENT ID (**R_P_ID**) FOR ADULT CAREGIVER.
- PRELOAD **STAFF_ID**.

DATA COLLECTOR INSTRUCTIONS

- COMPLETE WHEN AN NCS DATA COLLECTOR PICKS UP BIRTH BIOSPECIMENS FROM THE CHILD.
- IF BIOSPECIMENS FROM MULTIPLE CHILDREN ARE PICKED UP AT THE SAME LOCATION IN ONE ATTEMPT, A SEPARATE INSTRUMENT MUST BE COMPLETED FOR EACH CHILD.

- DISPLAY HARD EDIT IF **SPECIMEN_NUM_PU > 5**.
- LOOP THROUGH **SPECIMEN_TYPE**, **SPECIMEN_SAME_DATE** (IF APPLICABLE), **CBP01000**, **CBP02000**, **SPECIMEN_ID**, **SPEC_STORED**, **SPEC_STORAGE_COND**, AND **SPECIMEN_PICKUP_COND** UNTIL NUMBER OF LOOPS = **SPECIMEN_NUM_PU**.

- IF MORE THAN ONE SPECIMEN COLLECTED, SELECT ONE PER LOOP.

PROGRAMMER INSTRUCTIONS

CHARACTERS DASH HS01 (AA#####-HS01).

- IF **SPECIMEN_TYPE** = 2, DISPLAY "CORD BLOOD - LAVENDER TOP TUBE" AS {SPECIMEN TYPE} AND FORMAT SPECIMEN ID AS TWO ALPHA, SEVEN NUMERIC CHARACTERS DASH CL10 (AA#####-CL10).
- IF **SPECIMEN_TYPE** = 3, DISPLAY "CORD BLOOD - RED TOP TUBE" AS {SPECIMEN TYPE} AND FORMAT SPECIMEN ID AS TWO ALPHA, SEVEN NUMERIC CHARACTERS DASH CS10 (AA#####-CS10).
- IF **SPECIMEN_TYPE** = 4, DISPLAY "PLACENTA" AS {SPECIMEN TYPE} AND FORMAT SPECIMEN ID AS TWO ALPHA, SEVEN NUMERIC CHARACTERS DASH PC10 (AA#####-PC10).
- IF **SPECIMEN_TYPE** = 5, DISPLAY "PLACENTA" AS {SPECIMEN TYPE} AND FORMAT SPECIMEN ID AS TWO ALPHA, SEVEN NUMERIC CHARACTERS DASH PC11 (AA#####-PC11).
- IF **SPECIMEN_TYPE** = 6, DISPLAY "FULL PLACENTA" AS {SPECIMEN TYPE} AND FORMAT SPECIMEN ID AS TWO ALPHA, SEVEN NUMERIC CHARACTERS DASH PCXX (AA#####-PCXX).
