## A. JUSTIFICATION

- 1. This form is used by the Department of Veterans Affairs to request information for the proper maintenance of Veterans Mortgage Life Insurance accounts. The form is authorized by 38 USC 2106 and 38 CFR 8a.3(e). The expiration date is being added to the form.
- 2. The data collected is used by insurance personnel in the maintenance of Veterans Mortgage Life Insurance accounts.
- 3. VA Form 29-0543 is available on the One-VA web site in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. Efforts within VA are underway to provide a mechanism to allow the information to be submitted electronically with a recognized signature technology. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.
- 4. The information is not contained in any other VA records. Similar information is not available elsewhere.
- 5. The information does not involve any small businesses.
- 6. This form is designed for use by the Department of Veterans Affairs to maintain Veterans Mortgage Life Insurance accounts.
- 7. There are no special circumstances requiring that the collection of information be conducted in a manner inconsistent with the guidelines in 5 CFR Section 1320.6.
- 8. The Department notice was published in the Federal Register on January 15, 2014, Volume 79, Number 10, Pages 2755-2756. There are no persons outside the Department of Veterans Affairs with whom the material submitted was discussed. There were no public contacts. The information does not involve obtaining information from any state or local Government. There is no person or organization other than VA that will collect the information which is submitted by the insured. No comments were received in response to this notice.
- 9. The information collected is supplied by the respondent. No remuneration is made.

- 10. The information collection conforms with the Privacy Act of 1974 and is subject to the conditions of disclosure contained therein. The records are maintained in the system identified as 36VA00, "Veterans and Armed Forces Personnel United States Government Life Insurance Records VA" as contained in the Privacy Act Issuances, 1993 Compilation.
- 11. There are no questions of a sensitive nature.
- 12. Estimate of Information Collection Burden
  - a. Number of Respondents We estimate that approximately 540 forms a year will be received.
  - b. Frequency of Response On occasion
  - c. Annual Burden Hours 45 annual burden hours.
  - d. Estimated Completion Time We estimate that it will take approximately 5 minutes to complete this form. We arrived at this estimate by initiating a trial with a VA staff member unfamiliar with the forms.
  - e. According to the U.S. Bureau of Labor Statistics Average Hourly Earnings, the cost to the respondent is \$24, making the total cost to the respondents an estimated \$1,080. (45 burden hours X \$24 per hour)
- 13. This submission does not involve any record keeping costs.
- 14. Cost to Government:
