Supporting Statement Importation of Pomegranates from Chile Under a Systems Approach OMB No. 0579-0375

A. JUSTIFICATION

March 2014

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.

The United States Department of Agriculture, Animal and Plant Health Inspection Service (APHIS), is responsible for preventing plant diseases or insect pests from entering the United States, preventing the spread of pests and noxious weeds not widely distributed in the United States, and eradicating those imported pests when eradication is feasible. The Plant Protection Act authorizes the Department to carry out its mission.

Under the Plant Protection Act (7 U.S.C. 7701 <u>et seq.</u>) the Secretary of Agriculture is authorized to prohibit or restrict the importation, entry, or movement of plants, and plant pests to prevent the introduction of plant pests into the United States or their dissemination within the United States.

The regulations in "Subpart-Fruits and Vegetables" (7 CFR 319.56 through 319.56-58), prohibit or restrict the importation of fruits and vegetables into the United States from certain parts of the world to prevent the introduction and dissemination of plant pests that are new to or not widely distributed within the United States.

The importation of pomegranates from Chile, into the continental United States, is under a systems approach in which the fruit must be grown in a place of production that is registered with the Government of Chile, and certified as having a low prevalence of Brevipalpus chilensis. The fruit undergoes pre-harvest sampling at the registered production site. After the post-harvest process, the fruit is inspected in Chile at an approved inspection site. The phytosanitary certificate must accompany each consignment of fruit which includes an additional declaration stating that the fruit has been found free of Brevipalus chilensis. This determination is based on field and packinghouse inspections.

APHIS is asking OMB to approve for an additional 3 years, its use of these information collection activities associated with its efforts to prevent the spread of fruit flies and other plant pests from entering into the United States.

2. APHIS uses the following information activities to prevent the spread of fruit flies and other plant pests from entering into the United States. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

APHIS uses the following information collection activities to prohibit or restrict the importation, entry, or movement of plants and plant pests to prevent the introduction of plant pests into the United States or their dissemination within the United States.

Phytosanitary Certificate (Foreign Officials) w/Additional Declaration (Foreign Officials) - Each consignment of fruit must be accompanied by a phytosanitary certificate issued by the National Plant Protection Organization (NPPO) of Chile that contains an additional declaration stating that the fruit in the consignment was inspected and found free of <u>B</u>. <u>chilensis</u> based on field and packinghouse inspections. Requiring a phytosanitary certificate ensures that the NPPO of Chile has inspected the fruit and certified that the fruit meets the conditions for export to the United States.

<u>Production Site Registration</u> (Business) - The production site where the fruit is grown must be registered with the NPPO of Chile. Registration must be renewed annually.

<u>Marking of Cartons with Registration Number</u> (Business) – Harvested pomegranates must be placed in field cartons or containers that areas mark to show the official registration number of the production site. The registration number allows traceback to the production site if pest problems are found on fruit shipped to the United States. Problem production sites are then removed from the program until further mitigation measures are taken to reduce pest populations.

<u>List of Certified Production Sites</u> (Foreign Officials) - The NPPO of Chile is required to present a list of certified production sites to APHIS.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any considerations of using information technology to reduce burden.

APHIS has no control or influence over when foreign countries will automate these certificates.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use of the purpose described in item 2 above.

The information APHIS collects is exclusive to its mission of preventing the spread of plant pests and is not available from any other source.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

The information APHIS collects is the minimum needed to protect the United States from destructive plant pests while increasing the number and variety of fruits and vegetables that can be imported from other countries. APHIS has determined 40 percent of the respondents are small entities.

6. Describe the consequences to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

Failing to collect this information would cripple APHIS' ability to ensure pomegranates from Chile are not carrying plant pests. If plant pests (such as <u>Brevipalpus chilensis</u>) were introduced into the United States, growers would suffer hundreds of millions of dollars in losses.

On Wednesday, September 25, 2013, pages 58991-58992, APHIS published in the Federal Register, a 60-day notice seeking public comments on its plans to request a

3-year renewal of this collection of information. No comments from the public were received.

This information collection activity involves no payments or gifts to respondents.

No additional assurance of confidentiality is provided with this information collection. Any and all information obtained in this collection shall not be disclosed except in accordance with 5 U.S.C. 552a.

APHIS estimates the total annual cost to the respondents to be \$2,137.50. APHIS arrived at this figure by multiplying the total burden hours (150) by the estimated average hourly wage of the above respondents (\$14.25). The estimated average hourly salary is based on data from Chile's global services gambit.

13. Provide estimates of the total annual cost burden to respondents or recordkeepers resulting from the collection of information (do not include the cost of any hour burden in items 12 and 14). There is zero annual cost burden associated with the capital and start-up cost, maintenance cost, and purchase of services in connection with this program.

The number of respondents decreased from 7 to 3 - a decrease of 4 respondents, and the number of responses decreased from 287 to 285 - a decrease of 2 responses. The total burden hours decreased from 158 to 150 - a decrease of 8 hours. These adjustment

decreases resulted from a decrease in the number of respondents using the Phytosanitary Certificate and Production Site Registration forms in this collection.
