Procedure

Individual, one hour, interviews will be conducted with three parts:

- :10 pre-session briefing on research goal
- :45 user specific questions
- :05 post-questions opportunity for closing comments

Group, two hours, interviews will be conducted in four parts:

- :10 participant introductions
- :15 pre-session briefing on research goals
- 1:30 user specific questions
- :05 post-questions opportunity for closing comments

Each interview, regardless of whether it is individual or group, will have a specified script. An example script is outline below:

Questions

Potential questions include:

- 2. Were you involved in the 2010 Decennial Census? (If YES) 2a. What was that experience like? 2b. Were you part of a Complete Count Committee?
- 3. Tell me about a successful professional partnership you've been part of, aside from the U.S. Census Bureau. What made this partnership successful?
- 4. Tell me about a professional partnership that was not successful. What made this partnership unsuccessful?
- 5. If you could describe your ideal professional partner relationship, what would that look like?
- 6. To be the most successful you can be as an ambassador / partner with U.S. Census Bureau what are we missing? What do you want to see that we have not discussed?
- 7. What would you like to have happen or suggest in order to improve the Partner experience for the 2020 Decennial count?
- 8. If you work with other Partners, how do you communicate and coordinate events with them?
- 9. What tools (i.e.: event schedules, ordering posters and marketing items, training of partners and collaboration tools) do you believe are the needed to be successful?
- 10. If the platform was online, how would you access the tools (mobile, tablet and or laptop)?
- 11. What are a successful Partner's most critical needs?
