PURPOSE:

The Inventor Assistance Program at the United States Patent and Trademark Office (USPTO) wishes to increase intellectual property awareness among the independent inventors, minority-owned business owners, and owners of other small and medium-sized enterprises. To this end, the USPTO is developing an online web-based tool (Intellectual Property (IP) Awareness Assessment Tool) to assess the independent inventors/owners intellectual property awareness.
