

SUPPORTING STATEMENT
Immigrant Petition for Alien Workers
(Form I-140)
OMB No. 1615-0015

A. Justification.

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

This form is used to petition to classify an alien under sections 203(b)(1), 203(b)(2) or 203(b)(3) of the Immigration and Nationality Act (INA), 8 U.S.C. § 1153(b)(1), (b)(2), and (b)(3). *See* INA §§ 204(a)(1)(E) (8 U.S.C. 1154(a)(1)(E)); 8 C.F.R. § 204.5(a). A U.S. employer may file this petition to employ: (1) an outstanding professor or researcher who is recognized internationally as outstanding in the academic field; (2) a multinational executive or manager employed for at least 1 year by a firm, corporation, or other legal entity who seeks to enter the United States to continue to render services to the same employer or to a subsidiary or affiliate thereof in a managerial or executive capacity; (3) a member of the professions holding an advanced degree or its equivalent or a person who because of his or her exceptional ability in the sciences, arts, or businesses who will substantially benefit prospectively the national economy, cultural or educational interests, or welfare of the United States; (4) a skilled worker to perform labor, not of a temporary or seasonal nature, for which qualified United States workers are not available; (5) a member of the professions with a baccalaureate degree; or (6) a worker to perform unskilled labor, not of a temporary or seasonal nature, for which qualified United States workers are not available. In addition, any employer, person, or third party may file this petition: for an alien of extraordinary ability in the sciences, arts, education, business, or athletics which is demonstrated by sustained national or international acclaim; or to obtain a national interest waiver for an alien who is a member of the professions holding an advanced degree or who is an alien with exceptional ability in the sciences, arts, or business.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The data on this form is used by U.S. Citizenship and Immigration Services (USCIS) to determine eligibility for the requested immigration benefit. The form serves the purpose of standardizing requests for the benefit, and ensuring that basic information required to determine eligibility is provided by petitioners.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

Form I-140 is available online at <http://www.uscis.gov/i-140> to access, complete, save and submit paper-based forms to USCIS with supporting documentation and fees. This form can be e-filed at <http://www.uscis.gov/e-filing-i-140>. Petitioners may e-file by going to the e-filing login page, completing and submitting Form I-140 online. After Form I-140 is filed, petitioners will be provided a checklist of required initial evidence and supporting documents. Petitioners then mail all required initial evidence and supporting documentation to a physical address listed in the Form I-140 instructions. (Approximately 9 percent file electronically.)

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

This collection of information is unique to USCIS and is not conducted elsewhere. A review of USCIS Forms Inventory Report revealed no duplication of effort, and there is no other similar information currently available nor is the information accessible from other databases which can be used for this purpose.

- 5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.**

This information collection impacts small businesses or other small entities. USCIS estimates that approximately 53 percent would be considered small entities. USCIS has minimized the amount of information collected from petitioners by only requesting the information necessary to determine eligibility for the benefit requested. USCIS has also provided for electronic submission of the information as indicated in Question 3 above.

- 6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.**

The law requires that for a person to be classified as an immigrant under section 203(b)(1), 203(b)(2), or 203(b)(3) of the INA, he or she, or an employer or third party must file a petition using this information collection. See INA §§ 204(a)(1)(E) (8 U.S.C. 1154(a)(1)(E)); 8 C.F.R. § 204.5(a). This information collection requests information necessary for determining eligibility. Without the use of this information collection, the public will

not have a means to request this immigration benefit, which is one of the steps necessary before requesting lawful permanent resident status based on an employment category.

7. **Explain any special circumstances that would cause an information collection to be conducted in a manner:**
- **Requiring respondents to report information to the agency more often than quarterly;**
 - **Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
 - **Requiring respondents to submit more than an original and two copies of any document;**
 - **Requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
 - **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
 - **Requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**
 - **That includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**
 - **Requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

This information collection is conducted in a manner consistent with the guidelines in 5 C.F.R. § 1320.5(d)(2).

8. **If applicable, provide a copy and identify the data and page number of publication in the Federal Register of the agency's notice, required by 5 CFR 1320.8(d), soliciting comments on the information collection prior to submission to OMB. USCIS will be publishing a proposed rule, “*Enhancing Opportunities for High-Skilled H-1B and E-3 Nonimmigrants, CW-1 Nonimmigrants, and EB-1 Immigrants*,” RIN 1615-AC00,” in the *Federal Register*, allowing for a 60-day public comment period for this information collection. USCIS will address any comments it receives in the final rule.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

USCIS does not provide payments or gifts to respondents in exchange for a benefit sought.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

There is no assurance of confidentiality. The system of record notice associated with this information collection is [USCIS Benefits Information System \(DHS/USCIS-007\) which was published in the Federal Register on September 29, 2008 at 73 FR 56596](#). The privacy impact assessment associated with this information collection is [USCIS Benefits Processing of Applicants other than Petitions for Naturalization, Refugee Status, and Asylum \(CLAIMS 3, DHS/USCIS/PIA- 016 of September 5, 2008\)](#).

11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private. There are no questions of a sensitive nature.

* The above Average Hourly Wage Rate is derived from the [May 2012 Bureau of Labor Statistics Mean Hourly Wage for "All Occupations"](#). The wage rate of \$30.81 is calculated from the base average wage rate of \$22.01 times the wage rate benefit multiplier of 1.4. The selection of "All Occupations" represent the possibility that a respondents can be employed in any type of work; the collection is not targeting any specific category of employment.

** USCIS has estimated average time required to complete Form I-140 as 1.08 hours (1 hour, 5 minutes). This estimated time reflects gathering required documentation and information , reading the instructions, and completing the form/request to include preparation of statement and attaching necessary documentation, etc.

NOTES ON HOUR BURDEN:

USCIS has sought comments in conjunction with other information collection requests on how the burden of the following information collection requirements affects respondents. USCIS will revise its burden estimates based on the public comments received, its own expert analysis, and informational resources.

Translations. Respondents might incur burden for translations of documents in foreign languages. USCIS will evaluate the burden associated with requiring translations of supporting documents.

13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour

burden shown in Items 12 and 14).

There are no capital or start-up costs associated with this information collection. Any cost burdens to respondents as a result of this collection are identified in item 14. There is a \$580 fee charge for this information collection.

NOTES ON COST BURDEN:

This information collection may impose some out-of-pocket costs on respondents in addition to the time burden for the form's preparation. USCIS will consider public comments received and its own expert analysis for cost burden estimates.

Translations. Respondents might incur expenses for translations of foreign documents or documents prepared or issued in foreign languages.

Preparers. Some respondents may hire or request assistance from third parties in completing the Form I-821 and may incur costs to hire paid preparers for the preparation and submission of this form.

- 14. Provide estimates of annualized cost to the Federal government. Government Cost

USCIS establishes its fees using an activity-based costing model to assign costs to an adjudication based on its relative adjudication burden and use of USCIS resources. Fees are established at an amount that is necessary to recover these assigned costs, plus an amount to recover unassigned overhead (which includes the clerical, officer, and managerial time with benefits) and immigration benefits provided for free. As a consequence of USCIS immigration fees being based on resource expenditures related to the benefit in question, USCIS uses the fee associated with an information collection as a reasonable measure of the collection's costs to USCIS. USCIS has established the fee for Form I-140 at \$580.

The total estimated cost of the program to USCIS (\$44,746,420) is calculated by multiplying the estimated number of respondents (77,149) by the fee charge (\$580). This total includes the suggested average hourly rate for clerical, officer and supervisory time

with benefits, and the overhead cost for printing, stocking, and distributing and processing of this form (\$7,500).

15. Explain the reasons for any program changes or adjustments reporting in Items 13 or 14 of the OMB Form 83-I.

There is no change in the annual burden hours previously reported for this information collection. There is no change in the data being captured on the information collection instrument, and there is no change to the estimated annual burden hours as a result of this revision.

Under the proposed rule referenced in item #8, DHS is proposing to revise the Immigrant

Petition for Alien Worker, Form I-140, instructions to expand the current list of acceptable evidentiary criteria to include comparable evidence. Specifically, USCIS is adding a new paragraph 2.b under the General Requirements, Initial Evidence section to specify that if the listed categories of evidence do not readily apply, then the petitioner may submit comparable evidence to establish the alien's eligibility. Subsequent paragraphs were renumbered. This addition would harmonize evidentiary requirements for EB-1 outstanding professors and researchers with other employment-based immigrant categories that already allow for submission of comparable evidence.

16. For collections of information whose results will be published, outline plans for tabulation, and publication. Address any complex analytical techniques that will be used. USCIS does not intend to employ the use of statistics or the publication thereof for this collection of information.

17. If seeking approval to not display the expiration date for OMB approval of the information collection, explain the reasons that display would be inappropriate.

USCIS will display the expiration date for this information collection.
