We plan to issue a public notice soliciting private sector entities that will be required to file data with the FCC pursuant to 47 CFR 43.62 – providers of international services and circuits- to participate in usability testing of the electronic filing system that is being developed for filing the data. Participants will be provided with a link to a website where they can test the filing system. They will be asked to go through the system noting issues or problems with the system and then provide feedback on issues they encountered and suggestions to improve the usability of the system. The feedback will be used by the software developers to improve the electronic filing system. There will be two rounds of testing: one for the registration process and a second one for filing data.
