- Justification: Addresses both ineligible children and siblings' student status.

- Change: Added "Unstated Income Suspected?" field.
- Justification: Reminder for reviewer to address unstated income in subsequent income screens.

- Justification: Addressed POMS development procedures.

- Change: Added "Add Remarks" button.
- Justification: Available to document development issues.

- Justification: Addressed POMS development procedures.
- Change: Added systems data for the eligible spouse.
