Foreign Trade Zones Annual Reconciliation and Recordkeeping Requirement
1651-0051

Justification

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

In accordance with 19 CFR 146.25 and 146.4, foreign trade zone (FTZ) operators are required to account for zone merchandise admitted, stored, manipulated and removed from FTZs. FTZ operators must prepare a reconciliation report within 90 days after the end of the zone year for a spot check or audit by CBP. In addition, within 10 working days after the annual reconciliation, FTZ operators must submit to the CBP port director a letter signed by the operator certifying that the annual reconciliation has been prepared and is available for CBP review and is accurate. These requirements are authorized by Foreign Trade Zones Act, as amended (Title 19 U.S.C. 81a).

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

CBP uses the information to determine compliance with FTZ laws and regulations. CBP published a foreign trade zone manual which was a joint effort with the Foreign Trade Zones Board, The Bureau of Census and National Association of Foreign Trade Zones. The manual is for the use of existing and prospective foreign trade zone grantees, operators, and users in addition to CBP personnel responsible for supervising zone operators. The manual is a comprehensive document of which the information on annual reconciliation report preparation and certification is provided for on pages 94 and 95 and is available on CBP.gov. A copy of this manual will be included in this ICR.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

This is a recordkeeping requirement so zone operators are allowed to maintain their inventory and recordkeeping systems in any format that they select. The letter

certifying that the reconciliation has been prepared may be scanned and emailed or faxed to the port director.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

If this information were collected less frequently, CBP would not be able to determine compliance with FTZ laws.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.6.

Public comments were solicited through two Federal Register notices published on January 3, 2014 (Volume 79, Page 404) on which one comment was received, and on March 13, 2014 (Volume 79, Page 14263) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

There is no PII associated with this information collection. No assurances of confidentiality are provided to respondents.

Public Cost

The estimated cost to the respondents is \$17,015. This is based on the estimated burden hours (298) multiplied (x) hourly rate (\$57.10).

- 13. Provide an estimate of the total annual cost burden to respondents or recordkeepers resulting from the collection of information.**

There are no capital or start-up costs associated with this information collection.

- 14. Provide estimates of annualized cost to the Federal Government. Also provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment overhead, printing, and support staff), and any other expense that would not**

have been incurred without this collection of information.

The estimated annual cost to the Federal Government associated with this collection is \$62,796. This is based on the estimated number of responses (276) multiplied by the number of hours expended by CBP Field Auditors per response (4) = 1,104 multiplied by the average hourly rate (\$56.88).

15. Explain the reasons for any program changes or adjustments reported in Items 13 or 14 of this Statement.

Burden hours were added for the FTZ Certification letter. This is not a new requirement. This letter had been combined with the information collection for the FTZ Reconciliation record keeping on the previous submissions. The number of respondents/record keepers was updated from 260 to 276 to reflect the most recent data. There are no changes to these recordkeeping requirements or to the information collected.

This information collection will not be published.

17. If seeking approval to not display the expiration date, explain the reasons that displaying the expiration date would be inappropriate

This is a recordkeeping requirement, so there is no form on which to display the expiration date.

CBP does not request an exception to the certification of this information collection.

B. Collection of Information Employing Statistical Methods

No statistical methods were employed.
