Q7.	Prior to Project ARCH, how far did you typically travel to see <i>your primary care doctor / the kind of specialist you see</i> ?
Q8.	How far do you have to travel for Project ARCH-provided care? Has Project ARCH changed the length of time you have to wait to receive [primary or specialty] health care services? If yes, has it increased or decreased the time?
Q9.	How satisfied or dissatisfied are you with the care you have received from the Project ARCH-contracted provider(s)? How does your level of satisfaction with your Project ARCH care compare with your satisfaction with care you get directly from VA?
Q10.	Are there health care services that you would like to see offered by Project ARCH that are not currently available? If so, what are they?
