The survey will be available via a website and/or mail. If website is used, VA mental health staff may provide Veterans with computer access at the VA medical center or CBOC to complete the survey via a website before or after their outpatient mental health appointments. If mail is used, the survey will be mailed to Veterans who are receiving VA outpatient mental health services. The survey will be implemented during a select timeframe, at all medical centers.

Potential respondents will be identified based on encounters in VA outpatient mental health clinics as recorded in the VA Corporate Data Warehouse. Patients who received VA outpatient mental health services within a designated time window will be identified and contact information will be obtained from their medical records. This contact information will be used to either 1) mail out surveys or 2) provide clinic clerks with lists of potential respondents to invite. To allow assessment of bias in survey responses, and to allow for examination of differences in survey response based on patient characteristics, we will maintain a crosswalk linking the survey # to the scrambled social security number of the potential respondent. However, we emphasize that the surveys themselves will not include any personally identifiable information.
