

**Request for Approval under the “Generic Clearance for the Collection of

TITLE OF INFORMATION COLLECTION:

PROSTHESIS PATIENT SATISFACTION SURVEY

PURPOSE:

To ensure that the veteran is receiving proper treatment and instruction in the care and management of the prosthesis. This monitor is in place to meet Joint Commission health and safety standard of care.

DESCRIPTION OF RESPONDENTS:

(1) Individuals or Households

Veterans receiving new prosthesis will be asked to complete a Prosthesis Patient Satisfaction Survey. Contact will be made by mail or telephone within 30 days of receipt of prosthesis as identified in the patient prosthetic records. If the veteran is returning to Amputee Clinic for acceptance of the new limb, the veteran will be asked to fill out the Prosthesis Patient Satisfaction Survey at that time.

Prosthesis Satisfaction Survey tool will be used to record responses to specific questions pertaining to the Prosthetist and prosthesis. Any quality of care issues will be communicated to the Prosthetic Program Manager, Amputee Clinic Team and/or the VA Prosthetist.
