### Product Name

Enter the Product Name. The Product Name should follow the naming convention used in the [USDA's National Nutrient Database for Standard Reference \(http://www.nal.usda.gov/fnic/foodcomp/search\)](http://www.nal.usda.gov/fnic/foodcomp/search). Pattern the Product name after the following example: "Pizza, pepperoni topping, regular crust, frozen, cooked". The Product Name is limited to 255 characters.

## Product Name Shortened

The shortened product name is built using the USDA standard for abbreviations. The abbreviations used for the shortened product name can be found in [Appendix A of the USDA National Nutrient Database for Standard Reference](#). The Product Name Shortened should not be an abbreviation of each word in the full product name but rather should be a clear and concise shortened version of the full product name.

## Brand

Enter the Brand name that this product is commonly referenced as. The Brand for the product should be listed separately from the full or shortened product name. This field is limited to 40 characters.

## Unit UPC

Enter the 12-digit Universal Product Code (UPC). It is normally in the format of 0-12345-12345-0. The Unit UPC is very important for correctly matching the information on the product.

### Serving Information

The **Household Serving Amount** is a numeric value used to describe the amount of a specific **Household Serving Measure Description**. The two combined make up the **Household Serving Size**. The **Household Serving Measure Description** should be chosen from the following list of abbreviations:

CM	Centimeter	MG	Milligram (1000th of gram; weight)
CUP	Cup - 8 fluid ounces, volume	ML	Milliliter (fluid, volume)
FT	Feet (dimension)	OZ	Ounce (16 ounces = 1 pound; weight)
GAL	Gallon (fluid; volume)	FL OZ	Fluid Ounce (8 fluid ounces = 1 cup; volume)
GM	Gram (weight)	PACKAGE	Package/Box/Case/Bag
IN	Inch (12 inch = 1 foot; dimension)	PIECE	Piece/Portion/Unit/Item/Serving
KG	Kilogram (1000 grams; weight)	PT	Pint, fluid, volume
LB	Pound (weight)	QT	Quart, fluid, volume (4 quarts = 1 gallon)
LT	Liter (Fluid; volume)	TBSP	Tablespoon (16 tablespoons = 1 cup; volume)
M	Meter (dimension)	TSP	Teaspoon (3 teaspoon = 1 tablespoon; volume)

### Nutrient Information

The **Nutrient Serving Size** in grams may be equivalent to the **Household Serving Size** or the net weight on a single serve package if you are reporting Nutrition Facts (NLEA) data. For example, if the **Nutrient Serving Size** is based on one 57 gram single serve package, then the **Household Serving Amount** plus the **Household Serving Measure Description** (=Household Serving Size) would be 2.0 OZ for a non-liquid product. 57 grams divided by 28.35 grams per ounce equals the **Household Serving Size** of 2.0 ounces. Provide the nutrient values in the appropriate units designated in the nutrient list. Nutrients listed with an asterisk are Required; those without asterisks are Optional. Each of the nutritional fields can hold numbers from 0.00 to 9999999.999. Lastly, provide a **List of Ingredients** found in the product by order of predominance.
