These schools will be expected to participate in on-site data collection activities as well as to complete a menu survey during a target week. We will provide a \$50 check for foodservice managers after they complete the Menu Survey, in recognition of their conscientious efforts and important contributions to the study.

**Cafeteria Observations.** Mathematica's data collectors will observe one lunch and one breakfast period (if the school participates in the School Breakfast Program) in each sampled school to document characteristics of foodservice operations.

**Student and Parent Interviews**. Mathematica's data collectors will interview a small sample of students and their parents to obtain information on student characteristics, dietary intake, and participation and satisfaction with school meals. Students' height and weight will be measured as part of the interview. *In support of the student and parent interviews, data collectors will ask foodservice managers to identify available points of sale to students at each meal, and to indicate which sampled students received reimbursable meals on a selected day.*
