No personal information will be shared outside the study unless required by law. You and your child can skip any questions you do not wish to answer. If you do not wish to take part in the study at all, please complete and return the enclosed form. We cannot ensure that all willing households will be in the study. However, Mathematica will try to include all eligible households.
