- Have you ever talked with [foster care staff member] about things like your feelings towards someone that you like as more than a friend? Or have you talked with [foster care staff member] about a person that you might want to date or be close to by hugging or kissing?
  - **If yes, probe** - Do you remember when this talk took place? What was that talk like? How easy or comfortable was it talking with him or her about those things? Have you talked any more about it (is this a regular topic of discussion?) Did your being identified as [use term youth uses for their LGBTQ identity] come up in the conversation? If yes, what was it like discussing this?
  - **If no, probe** - Is there any reason why you haven't talked with him or her about the people you like as more than friends or about dating?
    - i. **If worker perceived as non-receptive or negative, probe further** - Is there anything that [foster care agency staff member] could do to make it easier for you to talk to him or her?
    - ii. Do you think it would make a difference for your experiences in foster care if you could talk to [foster care agency staff member] about these things? **If yes, probe**—what might be different then?
- We have talked about a lot of things today. Is there anything else that you think would be important for us to know about your time in the RISE program?
