<p>1. Reason for submitting the PTA: Renewal PTA</p> <p>FEMA’s Federal Insurance and Mitigation Administration (FIMA) manages the “Exemption of State-Owned Properties Under Self-Insurance” process. Under section 102 of the Flood Disaster Protection Act (FDPA) of 1973, Pub. L. No. 113-100 (codified at 42 U.S.C. § 4012(c)(1)), FEMA/FIMA can exempt a State from purchasing flood insurance for its properties located in a Special Flood Hazard Area (SFHA) if it implements an adequate self-insurance plan. FIMA regulations at 44 C.F.R. § 760.4 establish when FEMA/FIMA can accept a State’s self-insurance plan for its State owned properties in SFHAs, thus exempting it from purchasing flood insurance. The State’s Governor or other duly authorized official sends a letter (no official form or format) with documentation to FEMA/FIMA seeking exemption and explaining and certifying that their self-insurance plan meets FIMA regulations. The information collected is part of OMB ICR No. 1660-0013.</p>

The header identifies the source and destination of the packet, while the actual data is referred to as the payload. Because header information, or overhead data, is only used in the transmission process, it is stripped from the packet when it reaches its destination. Therefore, the payload is the only data received by the destination system.
