FEMA's Federal Insurance and Mitigation Administration (FIMA) manages the "Exemption of State-Owned Properties Under Self-Insurance" process. Under section 102 of the Flood Disaster Protection Act (FDPA) of 1973, Pub. L. No. 113-100 (codified at 42 U.S.C. § 4012(c)(1)) ,FEMA/FIMA can exempt a State from purchasing flood insurance for its properties located in a Special Flood Hazard Area (SFHA) if it implements an adequate self-insurance plan. FIMA regulations at 44 C.F.R. § 760.4 establish when FEMA/FIMA can accept a State's self-insurance plan for its State owned properties in SFHAs, thus exempting it from purchasing flood insurance. The State's Governor or other duly authorized official sends a letter (no official form or format) with documentation to FEMA/FIMA seeking exemption and explaining and certifying that their self-insurance plan meets FIMA regulations. The information collected is part of OMB ICR No. 1660-0013.
