

**SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION**

A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Collection of the information is necessary in order for the Secretary of Education to carry out the graduate Promoting Postbaccalaureate Opportunities for Hispanic Americans Program under Title V, Part B, Sections 511-514 of the Higher Education Act of 1965, as amended, 20 U.S.C. 1102-1102c. The information will be used in the evaluation process to determine whether proposed activities are consistent with legislated activities and to determine the dollar share of the Congressional appropriation to be awarded to successful applicants. The Promoting Postbaccalaureate Opportunities For Hispanic Americans Program provides grants to: (1) expand postbaccalaureate educational opportunities for, and improve the academic attainment of, Hispanic students; and (2) expand the postbaccalaureate academic offerings as well as enhance the program quality in the institutions of higher education that are educating the majority of Hispanic college students and helping large numbers of Hispanic and low-income students complete postsecondary degrees.

Information is collected under authority of 20 U.S.C. 1102-1102c; the Education Department General Administrative Regulations (EDGAR) in 34 CFR parts 74, 75, 77, 79, 82, 84, 85, 86, 97, 98, and 99; and the applicable regulations for this program in 34 CFR 606.2(a) and (b), 606.3, 606.4, 606.5, 606.6, 606.7, 606.10(b)(c)(d), and 606.30. <http://www.ecfr.gov/cgi-bin/text-idx?c=ecfr&sid=234dec1013048fbd71d68b7581a631c0&rgn=div5&view=text&node=34:3.1.3.1.6&idno=34>. This discretionary grant falls under the Streamlined Clearance Process for Discretionary Grant Information Collections (1890-0001) and is being submitted as a reinstatement without change.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

This collection of information is gathered electronically by the Department for the purpose of obtaining programmatic and budgetary information needed to evaluate applications and to make funding decisions based on the authorizing statute and the published selection criteria. This collection will be conducted annually, based on availability of funding for new grants under Title V, Part B.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision of adopting this means of collection. Also describe any consideration given to using technology to reduce burden.

The Office of Postsecondary Education is committed to the reduction of paperwork and has been collecting this information electronically since 2000. Electronic submission has reduced the burden for both the applicants and Department staff. Collection of information involves the use of electronic submission of responses via Grants.gov.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information submitted in each application is unique to each respondent. Moreover, the information changes annually. No other existing information collection can serve the purposes described in item 2.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden. Not applicable – small businesses or other small entities would not be impacted by this collection.

If the collection were not conducted annually, appropriated funds could not be spent.

Estimated burden hours for this collection of information are 75 hours. We estimate 100 respondents. Applications will be submitted annually.

- The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component.
