**DoD Central Adjudications Facilities Consolidation**  
 (OPS-7276)

Army, Navy, Air Force, DECA, DHP, DLSA, DSS, TJS, WHS

(U) Transfers resources from the Components to Washington Headquarters Services (WHS) to implement the Deputy Secretary of Defense's decision to consolidate various Defense adjudication functions into a single DoD Central Adjudication Facility (CAF), exclusive of Intelligence Agency adjudicative functions. (FY 2014, \$76.5 million and 563 civilian FTEs; FYDP, \$388.1 million and 563 civilian FTEs)

(U) Reduces the transferred resources for anticipated efficiencies resulting from the consolidation beginning in FY 2015. (FYDP, \$-14.1 million and -29 civilian FTEs)

(U) Provides resources to WHS to finance additional Homeland Security Presidential Directive-12 and suitability requirements and core common operational support. (FY 2014, \$+29.5 million and +104 civilian FTEs; FYDP, \$+129.9 million and +104 civilian FTEs)

DSS
