TITLE OF INFORMATION COLLECTION:

IMLS Community Catalyst Town Hall Evaluation.

PURPOSE:

The Institute of Museum and Library Services (IMLS) recently held a Town Hall where 65 museum, library, foundation, and non-profit representatives came together to discuss efforts made by museums and libraries to serve as catalysts in their community. IMLS plans to hold similar meetings in the future and would therefore like to solicit feedback from the participants on their experience at the Town Hall to inform how these might be organized going forward.

DESCRIPTION OF RESPONDENTS:

The survey would be sent to the 65 people who attended the Town Hall. Participants from the Town Hall worked in museums, libraries, foundations, and non-profits. Given the small group size and their participation levels at the Town Hall, we expect responses from all 65 participants.
