Supporting Statement Importation of Fresh Pitaya Fruit from Central America into the Continental United States OMB No. 0579-0378

A. JUSTIFICATION: February 2015

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.

The United States Department of Agriculture, Animal and Plant Health Inspection Service (APHIS), is responsible for preventing plant pests and noxious weeds from entering the United States, preventing the spread of plant diseases not widely distributed in the United States, and eradicating those imported pests and noxious weeds when eradication is feasible.

Under the Plant Protection Act (7 U.S.C. $7701 - \underline{\text{et}} \text{ seq}$), the Secretary of Agriculture is authorized to carry out operations or measures to detect, eradicate, suppress, control, prevent, or retard the spread of plant pests new to the United States or not known to be widely distributed throughout the United States.

The regulations in "Subpart – Fruits and Vegetables" (Title 7, Code of Federal Regulations (CFR) 319.56-1 through 319.56-71, referred to as the regulations), prohibit or restrict the importation of fruits and vegetables into the United States from certain parts of the world to prevent the introduction and dissemination of plant pests that are new to or not widely distributed within the United States.

APHIS allows the importation of fresh pitaya fruit from Central America into the continental United States. As a condition of entry, pitaya fruit from Central America will be subject to a systems approach that will include requirements for monitoring and oversight, establishment of pest-free places of production, and procedures for packing the pitaya fruit while continuing to provide protection against the introduction of quarantine pests.

APHIS is asking the Office of Management and Budget (OMB) to approve its use of these information collection activities for an additional 3 years, associated with its efforts to prevent the spread of plant pests and plant diseases into the United States.

2. Indicate how, by whom, and for what purpose the information is used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

APHIS uses the following information activity to allow the importation of fresh pitaya fruit from Central America into the continental United States.

<u>Production Site Certification (Foreign Government)</u> - The exporting country's National Plant Protection Organization (NPPO) must certify that each place of production has effective fruit fly trapping programs, and follows control guidelines, when necessary, to reduce quarantine pest populations. APHIS may monitor the places of production.

Review and Maintain Documents (Foreign Government) – The NPPO must review and maintain all forms and documents related to export program activities in places of production and packinghouses for a least 1 year and, as requested, provide them to APHIS for review.

Registration of Packinghouses (Foreign Government) – The packinghouses would have to be registered with the NPPO of the exporting country. In addition, the packinghouse could only accept fruit from registered places of production while the packinghouse is in use for exporting pitaya fruit to the United States.

Bilateral Workplan (Foreign Government) - The NPPO of the exporting country will be required to provide a workplan to APHIS that details the activities the NPPO will carry out to meet the requirements of the systems approach, subject to APHIS' approval of the workplan.

Records of Fruit Fly Detections and Update Records Each Time That Traps are Checked (Foreign Government) - The NPPO would have to keep records of fruit fly detections for each trap, update the records each time the traps are checked, and make the records available to APHIS inspectors upon request. The records would have to be maintained for at least 1 year.

<u>Shipping Documents Identifying the Places of Production (Business)</u> – Shipping documents identifying the place(s) of production in which the fruit was produced and the packing shed(s) in which the fruit was processed must accompany each lot of fruit presented for inspection at the port of entry to the United States. This identification must be maintained until the fruit is released for entry into the United States.

Phytosanitary Certificate with Additional Declaration (Foreign Government) - Each consignment of pitaya fruit must be accompanied by a phytosanitary certificate issued by the NPPO of the exporting country, containing an additional declaration stating that the fruit in the consignment was produced in accordance with requirements in 7 CFR 319.56-55.

<u>Production Site Registration (Business)</u> – The places of production producing pitaya for export to the United States must be registered with the NPPO of the exporting country.

Box Markings (Business) - Harvested pitayas must be placed in field cartons or containers that are marked to show the place of production so that traceback is possible.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also, describe any consideration of using information technology to reduce burden.

APHIS has no control or influence over when foreign countries will automate phytosanitary certificates or any other written documentation.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purpose described in item 2 above.

The information APHIS collects is exclusive to its mission of preventing the entry of injurious plant pests, diseases, and noxious weeds and is not available from any other source.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

The information APHIS collects in connection with this program is the minimum needed to protect the United States from insect pests such as the Mediterranean fruit fly (Medfly) from entering the United States. APHIS has determined that 100 percent of the respondents are small entities.

6. Describe the consequences to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

Failing to collect this information would cripple APHIS' ability to ensure that fresh pitaya fruit from Central America is not carrying fruit flies. If Medfly is introduced into growing areas of the United States, growers in these areas would suffer hundreds of millions of dollars in losses.

7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with the general information collection guidelines in 5 CFR 1320.5.

- requiring respondents to report information to the agency more often than quarterly;
- requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- requiring respondents to submit more than an original and two copies of any document;

There are no special circumstances associated with this information collection.

On Thursday, August 14, 2014, page 47612-47613, APHIS published in the Federal Register, a 60-day notice seeking public comments on its plans to request a 3-year renewal of this collection of information. No comments from the public were received.

9. Explain any decisions to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

This information collection activity involves no payments (other than appropriate, program-related payments) or gifts to respondents.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

No additional assurance of confidentiality is provided with this information collection. Any and all information obtained in this collection shall not be disclosed except in accordance with 5 U.S.C.552a.

This information collection activity asks no questions of a personal or sensitive nature.

Respondents are growers and shippers from Central America, and the National Plant Protection Organization. The total burden cost to the respondents is \$6,601.00. APHIS arrived at this figure by multiplying the total hours (287) by the estimated average hourly wage of the above respondents (\$23.00). $287 \times $23.00 = $6,601.00$

The hourly wage was provided by APHIS' International Services via plant protection officials in Honduras, Costa Rica, and Guatemala.

Provide estimates of the total annual cost burden to respondents or recordkeepers resulting from the collection of information, (do not include the cost of any hour burden shown in items 12 and 14). The cost estimates should be split into two components: (a) a total capital and start-up cost component annualized over its expected useful life; and (b) a total operation and maintenance and purchase of services component.

There is zero annual cost burden associated with capital and start-up costs, maintenance costs, and purchase of services in connection with this program.

The estimated cost to the Federal Government is \$8,811. (See APHIS Form 79.)

There is a program change in burden hours from 122 to 287, totaling an increase of 165 hours. There is also a program change in the number of responses from 141 to 100,148, totaling an increase of 100,007 annual responses. The number of respondents stayed the same, 27, however, the increase in responses and burden hours is due to the addition of production site registrations and box markings in this collection. These two entries were inadvertently omitted in the last information collection package.

APHIS has no plans to tabulate or publish the information collected.

There are no USDA forms associated with this information collection.
