## i. INTRODUCTION

Because space is limited and we cannot provide extra services to all the parents who would like to receive them, the research team created a computer program to randomly select which parents will be able to participate in our program. If you agree to participate in the study, the computer will place you into one of two groups: one group will receive extra services through the [INSERT STATE PROGRAM NAME HERE] at no cost to them; the other group will not receive services beyond the services they would have received even if the study was not being conducted. 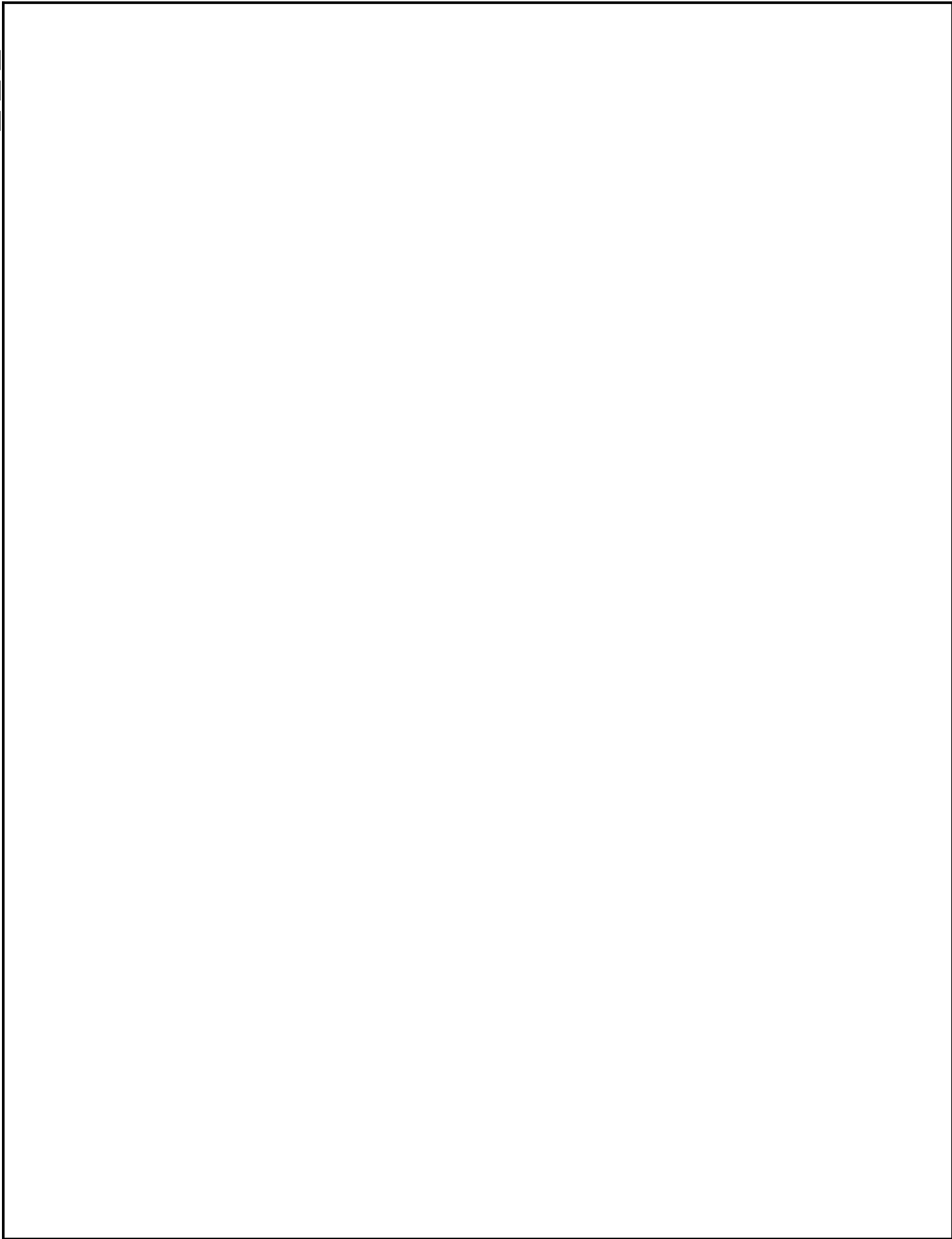

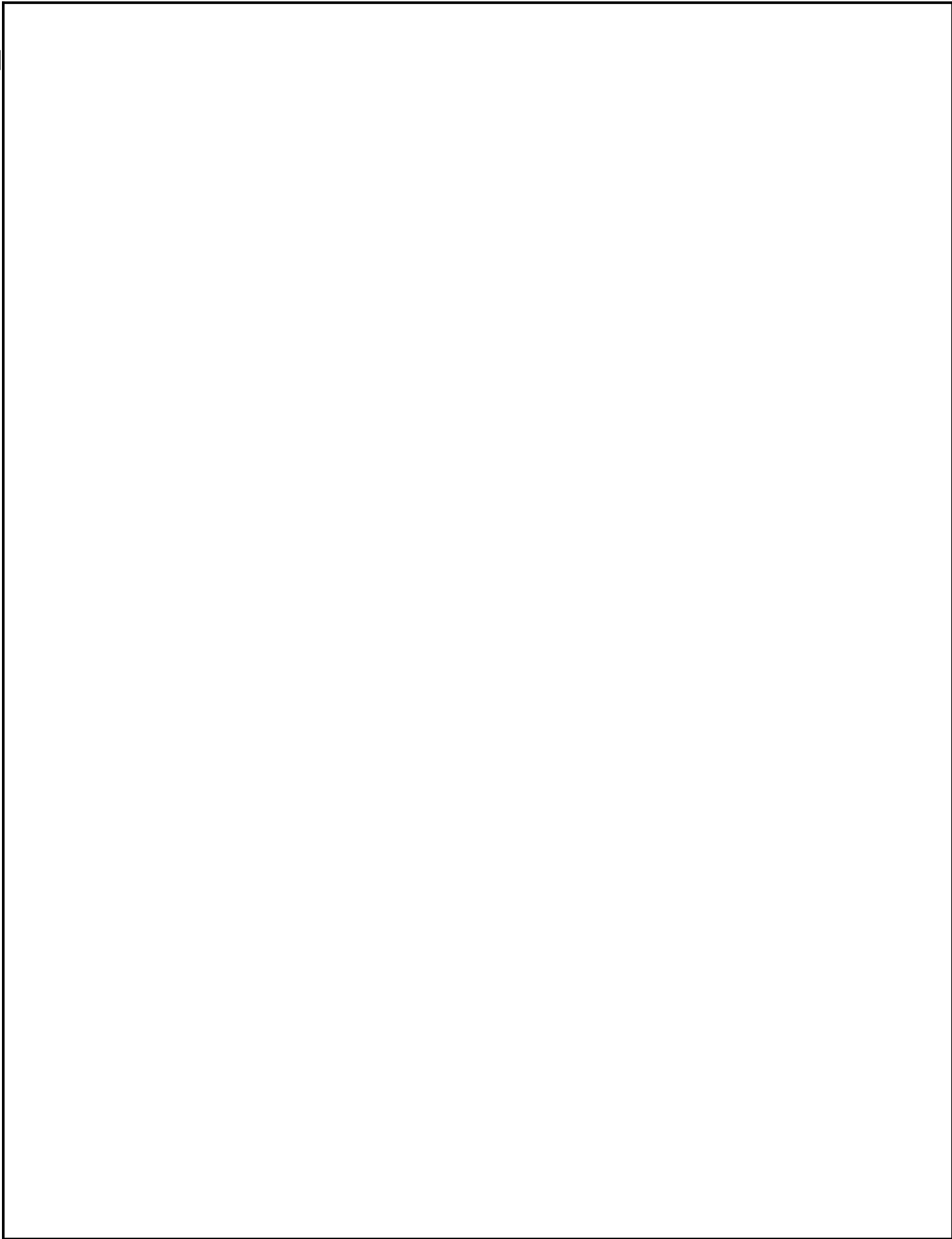
