## **Procedure**

## **National Clearinghouse on Rehabilitation Training Materials Website Survey**

The site will have a "Send Us Your Feedback" link on each page. When users select the link, the survey (Send Us Your Feedback Survey) will open into a new window with five simple questions on SurveyMonkey. Each question will have 2-4 choice responses – with dynamic comment boxes, prompting users to provide more detail for negative responses. A general comment box will also be presented. The responses are voluntary and confidential. Respondents will be able to quickly select their choices, type in any comments and submit their responses. A confirmation of submission will appear.


