TITLE OF INFORMATION COLLECTION: Safeguards & Security (S&S) Policy Information Resource Survey Questions

PURPOSE: The survey will be used primarily to ascertain whether the S&S Policy Information Resource web page is providing useful information for its users.

DESCRIPTION OF RESPONDENTS: The targeted group of respondents consists of users that have or plan to use the application. This collection is intended for DOE federal employees and contractors. Members of the general public may be able to access and respond to the survey questions when visiting the web site. However, the general public is not the intended sample

audience and its associated responses will likely be discarded.
