A. Justification

This form is used by the policyholder to claim disability insurance benefits on NSLI and USGLI policies. The information requested is authorized by law, 38 U.S.C. sections 1912, 1915, 1942 and 1948.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

The information collected on the form is used by Department of Veterans Affairs (VA) to establish the insured's eligibility for disability insurance benefits. This application is to be completed by veterans who have government life insurance and become totally disabled.

VA Form 29-357 has been added to our VBA website for downloading. The insured is now able to complete the form electronically, print and submit the claim by mail.

The information is not contained in any other VA records. Similar information is not available elsewhere.

The information does not involve any small businesses.

This form is designed for use by the insurance activity to determine the insured's eligibility for disability insurance benefits.

The information collection conforms with the Privacy Act of 1974 and is subject to the conditions of disclosure contained therein. The records are maintained in the system identified as 36VA00, "Veterans and Armed Forces Personnel United States Government Life Insurance Records - VA" as contained in the Privacy Act Issuances, 1993 Compilation.

Estimate of Annual Information Collection Burden:

- c. Annual Burden Hours: 14,175
- d. Estimated Completion Time: 1 hour and 45 minutes (We arrived at this estimate by initiating a trial with a VA staff member unfamiliar with the forms.)
- e. According to the U.S. Bureau of Labor Statistics Average Hourly Earnings, the cost to the respondent is \$24, making the total cost to the respondents an estimated \$340,200.00. (14,175 burden hours X \$24 per hour).

This submission does not involve any record keeping costs.
